RETROACTIVELY,  
AUTHORIZING/ THE MAYOR'S OFFICE OF COMMUNITY DEVELOPMENT TO ACCEPT AND EXPEND A GRANT IN THE AMOUNT OF \$468,750 FROM THE U.S. DEPARTMENT OF LABOR FOR THE MISSION DISTRICT SCHOOL-TO-CAREER PROGRAM.

WHEREAS, the City and County of San Francisco has developed a School-to-Career program located in the Mission District, a federally designated Enterprise Community; and,

WHEREAS, one-third of the students in this neighborhood are English-language learners, half come from low income families, and 87 percent are minority; and,

WHEREAS, the City and County of San Francisco, through the School-to-Career Partnership, has an infrastructure that connects students, employers, parents, labor, community-based organizations and schools; and,

WHEREAS, this project will directly benefit approximately 800 at-risk students and out of school youth by making stronger connections between the existing School-to-Career program and Mission District schools; and

WHEREAS, The grant budget approved by the Department of Labor includes provision for indirect costs of \$27,707; now, therefore, be it

RESOLVED, that the Mayor's Office of Community Development is authorized retroactively, to sign and approve on behalf of the City and County of San Francisco the attached grant award including any extensions or




