17 for a two-year term ending April 27, 2024;

18 Laura Stein, seat 6, succeeding themselves, term expiring April 27, 2022, must be a  
19 member of the public experienced in consumer advocacy, for a two-year term ending April 27,  
20 2024;

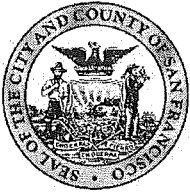
21 Matthew Yankee, seat 7, succeeding themselves, term expiring April 27, 2022, must be a
