

1 [Stop Sign at 15th Avenue and Ortega Street]
2 URGING THE DEPARTMENT OF PARKING AND TRAFFIC TO INSTALL STOP SIGNS AT
3 THE INTERSECTION OF 15TH AVENUE AND ORTEGA STREET TO IMPROVE THE
4 TRAFFIC SAFETY IN THE AREA AND TO INSTALL THE STOP SIGN SIGNS WITHIN
5 30 DAYS AFTER THE MAYOR SIGNS THE LEGISLATION.

6 WHEREAS, The stretch of 15th Avenue in Golden Gate Heights is a
7 residential street with a speed limit of 25 miles per hour; and,

8 WHEREAS, Neighbors along 15th Avenue near Ortega Street have
9 complained about the excessive speeding along 15th Avenue and noted
10 that speeding is a very common occurrence; and,

11 WHEREAS, For three blocks along 15th Avenue, including its
12 intersection with Ortega Street, there are no stop signs to slow down
13 traffic; and,

14 WHEREAS, On 16th Avenue, a similar residential corridor one
15 street over from 15th Avenue, stop signs have been effective in
16 reducing speeding; and,

17 WHEREAS, Over the years, neighbors have made repeated requests
18 for the installation of stop signs and increased enforcement measures
19 to ensure pedestrian safety and prevent excessive speeding on 15th
20 Avenue; and,

21 WHEREAS, Despite residents' efforts, the problem of speeding
22 vehicles on 15th Avenue has persisted; now therefore be it,

23 RESOLVED, That the Board of Supervisors of the City and County
24 of San Francisco hereby urges the Department of Parking and Traffic
25 to install stop signs at the intersection of 15th Avenue and Ortega


