11 WHEREAS, The Police Department recommends that the liquor license application be approved with
12 conditions; now, therefore, be it

13 RESOLVED, That in accordance with Section 23958.4 of the California Business and Professions Code,
14 the Board of Supervisors of the City and County of San Francisco hereby determines for the foregoing reasons that
15 the issuance of a Type 20 off-sale beer and wine alcoholic beverage control license, to Dee Ann Catlin for Smart
16 and Final #570, located at 880 Harrison Street will serve the convenience of the people of the City and County of
17 San Francisco.

18 Conditions: 1) No Sales of fortified wines. 2) No sales of malt liquors in single cans or quart sizes. 3) No
19 sales of distilled spirits in mini-bottles, ½ pints or pints (750 ml or larger sizes only). 4) No sales of any single can
20 or bottle or beer (six pack only).




