Resolution approving the increase of \$2,563,000 for Municipal Railway Contract No. CS-132, Quality Assurance and Construction Management Services for Phase I of the Third St. Light Rail Transit Project.

WHEREAS, On June 20, 2000, the Municipal Transportation Agency (MTA) Board of Directors adopted Resolution No. 00-070, which authorized the Director of Transportation to advertise a Request for Proposals (RFP), select the most qualified proposer, and negotiate a contract with that proposer to procure quality assurance and construction management services at a cost not to exceed \$16,000,000.00, and for a term not to exceed five years; and,

WHEREAS, On July 3, 2001, the MTA Board of Directors adopted Resolution No. 01-080, which approved the award of Contract No. CS –132, Quality Assurance and Construction Management Services for Third Street Light Rail Transit Project, Phase I, to Sverdrup Civil Inc., for an amount not to exceed \$16,000,000.00 and a term not to exceed five years; and,

WHEREAS, On August 6, 2001, the Civil Service Commission approved Municipal Railway Contract No. CS-132 by adopting PSC No. 4020-01/02; and,

WHEREAS, On August 24, 2001, the Board of Supervisors adopted Resolution No. 658-01, which approved the award of Municipal Railway Contract No. CS-132 to Sverdrup Civil Inc., for an amount not to exceed \$16,000,000.00 and a term not to exceed five years; and.

WHEREAS, On April 17, 2007, the MTA Board of Directors adopted Resolution 07-053 which authorized the Executive Director of Transportation to execute Agreement Modification No. 2 for an additional term not to exceed 671 days for a total term not to exceed December

WHEREAS, Resolution 07-053 also authorized the Executive Director to execute Agreement Modification No. 3 for an additional amount not to exceed \$2,563,000.00 for a total contract amount not to exceed \$18,563,000.00 after the Agreement has been approved by the Board of Supervisors and the Civil Service Commission; now, therefore, be it

RESOLVED, That the Board of Supervisors approves amendment of Municipal Railway Contract No. CS-132 with Jacobs Civil, Inc. for Quality Assurance and Construction Management Services for Third Street Light Rail Transit Project, extending the term of the contract not to exceed 671 days and increasing the amount of the contract \$2,563,000.00, for a total amount not to exceed \$18,563,000.00.
