13 the payment of \$100,000. The lawsuit involves alleged medical negligence.

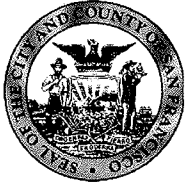


