4 **a Type-48 on-sale general public premises liquor license to Triple Chan**
5 **Enterprises, to do business as the RM212, located at 690 Sacramento Street**

8 **Section 23958.4; and requesting that the California Department of Alcoholic**

11 WHEREAS, Triple Chan Enterprises is seeking the person-to-person, premise-
12 to-premise transfer of a Type-48 on-sale general public premises liquor license to do
13 business as RM212, located at 690 Sacramento Street (District 3); and

14 WHEREAS, The Planning Department has verified that the area is properly
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed zero protests and zero letters of
17 support with the Department of Alcoholic Beverage Control under California Business
18 and Professions Code, Section 24013, and recommends that the Department of
19 Alcoholic Beverage Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the
21 following: 1) Petitioner(s) shall actively monitor the area under their control in an effort
22 to prevent the loitering of persons on any property adjacent to the licensed premises as
23 depicted on the ABC-253; 2) (1) Except as provided in Condition 2 below, no noise shall
24 be audible beyond the area under the control of the licensee; and 3) (2) Any noise
25 caused by entertainment or amplified sound that is subject to the provisions of an active

1 Entertainment Permit issued by the San Francisco Entertainment Commission shall be
2 authorized in accordance with the limits established by that Entertainment Permit,
3 including any limitation on hours during which entertainment or amplified sound is

16 business as the RM212, located at 690 Sacramento Street, will serve the public
17 convenience or necessity of the City and County of San Francisco; and, be it

18 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
19 San Francisco hereby endorses and adopts the recommendations of the Police
20 Department listed above and recommends that the Department of Alcoholic Beverage

Dear Mr. Carroll,

In May of 2023, my broker Jim Saxton helped Triple Chan Enterprises d.b.a. RM 212 to file the ABC application to obtain a type 48 license from seller, Tsaan Wai Lum of SF Project X, LLC. The license will be changing locations from 1414 Market Street to 690 Sacramento Street in San Francisco. The proposed operating hours will be 4pm- 12am Monday thru Sunday. On June 24th, we posted the 30 day notice on the window obligatory to ABC's requirement and it is still currently visible on the front door. My establishment has been in business as a Type 41 bar and restaurant since January 2017. As we were about the flourish, the unfortunate event of COVID loomed upon us causing the business to drop significantly. Although we were able to survive the pandemic thanks to a lenient landlord and support from family, friends and neighbors, new foot traffic was not apparent. However, companies are now enforcing more employees to return back to work so we hope that business can revive. During the past few years, costs of goods and labor have gone up tremendously as many in the food industry are struggling to survive. My partner and I have always seen potential in our area especially as Chinese Americans, we want to be able to help this area flourish so we refuse to give up. In turn, as resilient as we can be, we can't compromise our livelihood hence our decision to transition into the bar business. We want to be able to help the economy of the fidi/chinatown area and be able to help ourselves survive during this time. Hence, we hope that the city of San Francisco can help us pursue our continued efforts to maintain the livelihood for workers, neighbors and tourists visiting the downtown area.

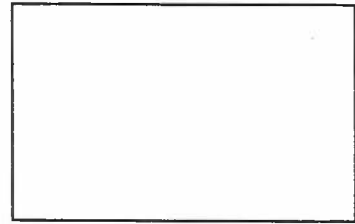
