4 **the City and County of San Francisco for \$45,000; the lawsuit was filed on October 3,**
5 **2019, in San Francisco Superior Court, Case No. CGC-19-579765; entitled Jonathan**
6 **Valladares v. City and County of San Francisco, et al.; the lawsuit involves alleged**
7 **personal injury from vehicle collision.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Jonathan Valladares v. City and
12 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-19-579765 by
13 the payment of \$45,000. The lawsuit involves alleged personal injury from vehicle collision.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 October 3, 2019, and the following parties were named in the lawsuit: Plaintiff: Jonathan
16 Valladares; Defendants: City and County of San Francisco, Wayland Gin, Vincent Capurro,
17 AMR Enterprises dba Skylark Limousine and Sukh Deep Singh.
