

1 [Agreement Amendment - Sunset Scavenger Company, Golden Gate Disposal &
2 Recycling Company, Recology San Francisco - Refuse Collection - Not To Exceed
3 \$53,500,000]

4 **Resolution approving the Second Amendment to the Refuse Collection**
5 **Agreement between the City and County of San Francisco and Sunset Scavenger**
6 **Company d/b/a Recology Sunset Scavenger, Golden Gate Disposal & Recycling**
7 **Company d/b/a Recology Golden Gate, and Recology San Francisco**
8 **(Contractors), increasing the total not to exceed amount of the Agreement from**
9 **\$48,000,000 to \$53,500,000 under Charter, Section 9.118(b), with no change to the**
10 **term length to expire on November 30, 2020, to commence upon approval by the**
11 **Board of Supervisors.**

13 WHEREAS, The Board of Supervisors approved Resolution No. 444-14 on
14 November 25, 2014, waiving a competitive solicitation process and authorizing a refuse
15 collection agreement for \$40,000,000 with Recology San Francisco, Recology Golden
16 Gate, and Recology Sunset Scavenger for the term of December 1, 2014, through
17 November 30, 2020; and

18 WHEREAS, The Board of Supervisors approved Resolution No. 493-19 on
19 November 19, 2019, increasing the total not to exceed amount of the Agreement from
20 \$40,000,000 to \$48,000,000 under Charter, Section 9.118(b); and

21 WHEREAS, This Agreement is approaching the contract amount of
22 \$48,000,000; and

23 WHEREAS, The Charter, Section 9.118(b), provides that when agreements of
24 \$10,000,000 or more are amended to increase the not-to-exceed amount by \$500,000

1 or more, then such amendment shall be subject to approval of the Board of Supervisors
2 by resolution; and

3 WHEREAS, The Agreement and the proposed Second Amendment are on file
4 with the Clerk of the Board of Supervisors in File No. _____, which are
5 hereby declared to be part of this Resolution as if set forth fully herein; now, therefore
6 be it,

7 RESOLVED, That the Board of Supervisors approves the Second Amendment
8 to the Contract with Recology San Francisco, Recology Golden Gate, and Recology
9 Sunset Scavenger as described above; and, be it

10 FURTHER RESOLVED, That within 30 days of the contracts being fully
11 executed by all parties, the Purchaser and Director of the Office of Contract
12 Administration shall provide the final contracts to the Clerk of the Board for inclusion
13 into the official file.
