4 **Resolution concurring with the Airport Commission's Declaration of Emergency in**  
5 **response to the boiler failure at the Airport and approving a contract between the**  
6 **Airport Commission and Ghiloti Brothers for the purchase of two new boilers.**

8 WHEREAS, On December 23, 2008, one of the primary boilers in the Central Plant at  
9 San Francisco International Airport failed and has been decommissioned; and

10 WHEREAS, The aged, deteriorating condition of the remaining boilers necessitates the  
11 immediate replacement of the failed one and an unreliable backup unit in order that the  
12 traveling public be provided with heat and hot water during the winter months of 2009-2010;  
13 and,

14 WHEREAS, The normal design and contracting process for the purchase and  
15 installation of a major boiler can require up to twenty months in duration; and,

16 WHEREAS, An Energy Efficiency Audit completed by the San Francisco Public  
17 Utilities Commissions found that replacing boilers at the Airport's Central Plant with two new  
18 energy efficient boilers would both save energy and meet the Bay Area Air Quality District's  
19 new emission standards; and,

20 WHEREAS, The Airport Commission's Declaration of Emergency, on file with the Clerk  
21 of the Board of Supervisors in File No. 090355, which is hereby declared to be a part of this  
22 resolution as if set forth fully herein; now, therefore, be it

23 RESOLVED, That recognizing the need for a new boiler to be in place for the winter of  
24 2009-2010 and the new emission requirements enacted by the Bay Area Air Quality Board,  
25 this Board of Supervisors does hereby concur with the Airport Commission's Declaration of

1 Emergency for the purchase of two replacement boilers and approves the contract between  
2 the Airport Commission and Ghiloti Brothers for the purchase of said boilers.


