Ordinance authorizing settlement of the lawsuit filed by Linda Chen against the City and County of San Francisco for \$350,000; the lawsuit was filed on November 7, 2014, in San Francisco Superior Court, Case No. CGC 14-542604; entitled Linda Chen v. San Francisco Police Department, et al.; the lawsuit involves an employment dispute.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Linda Chen v. San Francisco Police Department, et al., San Francisco Superior Court, Case No. CGC 14-542604 by the payment of \$350,000. The lawsuit involves an employment dispute.

Section 2. The above-named action was filed in San Francisco Superior Court on November 7, 2014, and the following parties were named in the lawsuit: Plaintiff: Linda Chen; Defendants: City and County of San Francisco and Avery Parker.


