2 **Resolution commending and honoring Barbara Kaufman for her distinguished service**
3 **as Supervisor of the City and County of San Francisco.**

5 WHEREAS, Supervisor Barbara Kaufman was elected in 1992 and re-elected in 1996
6 to serve the people of the City and County of San Francisco; and,

7 WHEREAS, Supervisor Kaufman has served this community with sensitivity,
8 dedication, a strong sense of ethics, and devotion for over eight years as a member of its
9 Legislative Body; and,

10 WHEREAS, Supervisor Kaufman served as President of the Board of Supervisors
11 from December 1995 to January 1998, having received the highest number of votes in the
12 1995 Supervisorial election; and,

13 WHEREAS, Supervisor Kaufman served as the Mayor's appointee to the League of
14 California Cities, and also served as a member of the San Francisco County Transportation
15 Authority; Golden Gate Bridge, Highway and Transportation District Board; served on
16 numerous Board of Supervisors' Standing Committees, including, but not limited to, serving
17 four years as Vice-Chair of the Finance Committee, Chair of the Audit and Government
18 Efficiency Committee; and served on the Committee on Information Technology, the Capital
19 Improvement Advisory Committee, and the Executive Compensation Committee; and,

20 WHEREAS, Supervisor Kaufman authored the new Charter and led the voter approval
21 process for the 1996 Charter revision, and undertook the daunting task of updating and
22 streamlining the City and County of San Francisco Administrative Code, section by section,
23 line by line; and,

1 WHEREAS, Supervisor Kaufman authored legislation on many different issues
2 including numerous fiscal reforms, and economic development measures such as the new
3 jobs tax credit, business improvement district, and newsrack zones; and

4 WHEREAS, Supervisor Kaufman created two successful homeless pilot projects,
5 crafted a neighborhood services department, and authored legislation on domestic violence
6 prevention and other women's issues such as CEDAW; now, therefore, be it

7 RESOLVED, That the members of the Board of Supervisors, on behalf of the officers,
8 employees, and citizens of this City, do hereby take public recognition of the distinguished
9 contributions which Supervisor Barbara Kaufman has made to the welfare of this community,
10 and do express to her their appreciation for her high quality work, their thanks for her
11 presence, and their hopes for the best in her future endeavors; and, be it

12 FURTHER RESOLVED, That a framed copy of this resolution be tendered to
13 Supervisor Barbara Kaufman as a token of the great affection and respect in which she is
14 held by the Board of Supervisors.




