7 **continue production of a monthly newsletter to promote programs, services and**
8 **special events offered by the Public Library.**

10 WHEREAS, The San Francisco Public Library provides quality programs, services, and
11 special events and exhibits for the residents of the City; and

12 WHEREAS, The San Francisco Public Library seeks to actively promote the services,
13 programs, and special events it offers the diverse communities and neighborhoods it serves;
14 and,

15 WHEREAS, The San Francisco Public Library is continually seeking ways to expand
16 community participation in the programs and services it offers; and,

17 WHEREAS, The Friends and Foundation of the San Francisco Public Library is a non-
18 profit organization that seeks to provide support for the Public Library by providing resources
19 to accomplish Library goals; and,

20 WHEREAS, The San Francisco Public Library has requested, and the Friends and
21 Foundation of the Public Library have agreed to provide ~~\$22,189~~ \$14,643 for a half-time
22 Curator II to conduct outreach activities to neighborhoods and communities served by Branch
23 Libraries thereby increasing community awareness and participation in programs offered by
24 the Library; and,

1 WHEREAS, The San Francisco Public Library has requested and the Friends and
2 Foundation of the Public Library have agreed to provide ~~\$22,153~~ \$14,616 for a half-time
3 Public Relations Officer to write, edit, and manage the production of "At the Public Library" a
4 monthly publication that promotes Library services, programs, and special exhibits and
5 programs for children, youth, and adults; and, provides information on Library locations,
6 hours, and general items of interest; and,

7 WHEREAS, The San Francisco Public Library proposes to maximize use of available
8 gift funds by not including indirect costs in the gift budget; now, therefore, be it

9 RESOLVED, That the San Francisco Public Library be authorized to accept and
10 expend a gift of ~~\$44,342~~ \$29,259 from the Friends and Foundation of the San Francisco
11 Public Library and to establish ~~limited-term~~ temporary, as needed positions to conduct
12 outreach activities geared to the neighborhood communities served by the Library and to
13 continue the publication of "At the Public Library".


