9 Be it ordained by the People of the City and County of San Francisco:


10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Andre Price, et al. v. City and County  
12 of San Francisco, et al., San Francisco Superior Court, Case No. CGC-14-543349 by the  
13 payment of \$100,000. The lawsuit involves an employment dispute.
