Re: Support for SFPUC nominees Avni Jamdar and Joshua Arce

The Sierra Club supports the appointment of Avni Jamdar and Joshua Arce to the San Francisco Public Utilities Commission (SFPUC). Both nominees have strong environmental credentials and impressed us with their subject matter expertise. We urge you to approve their appointments.

The Sierra Club is an amicus supporting the EPA in the SF vs EPA lawsuit. The current SFPUC General Manager and the City Attorney–both of whom were appointed by the Mayor–are continuing to carry forward a lawsuit that would harm our local waters and could have serious ramifications for how the EPA is able to regulate water quality across the country. We need SFPUC Commissioners that will more seriously prioritize our water and our environment.

The Sacramento-San Joaquin Delta and San Francisco Bay form the largest estuary on the West Coast south of Alaska. Such estuaries, where fresh and saltwater mix, are among the richest zones of biological productivity and diversity. Human impacts, however, have brought this ecosystem to the brink of collapse. We urgently need a dramatic change in direction from the SFPUC.

We are facing a climate emergency which requires immediate action. The high cost of electricity relative to the alternatives and the high cost of transitioning a home to electric appliances deters many residents from making the switch. We need the SFPUC to make electrification more attractive financially so that we get the mass shift away from gas that is so urgently needed.

We are encouraged by Jamdar and Arce's nominations and we support their appointment.
