 23 **Section 2. Authorization to Accept and Expend Funds.**

24 The United States Department of Agriculture provides funds to the City and
 25 County of San Francisco to operate the Summer Food Service Program. The funding

1 will provide children ages 0-18 years with free lunches and snacks during the summer
2 months from June to August 2009. An average of 5,200 children will be served lunches
3 and snacks each day from June 22nd until August 14th 2009 at over 100 sites throughout
4 the City. The United States Department of Agriculture has created a pilot Year-Round
5 Feeding Program to provide reimbursement for sites to provide an average of 1500
6 afterschool snacks daily for children at 50 sites based on the Federal fiscal year
7 October 2009 - September 2010. The grant budget does not include indirect costs
8 because DCYF wants to maximize the use of the grant funds on direct services.
9 Therefore, this ordinance hereby waives inclusion of indirect costs in the grant budget.
