4 TRAINING IN THE AREA OF WORKERS' RIGHTS WITHIN THE LATINO COMMUNITY.

5 WHEREAS, On January 2, 1982, The Instituto Laboral de la Raza was  
6 founded to provide much needed services to low income workers and their  
7 families throughout the Bay Area; and,

8 WHEREAS, The Instituto works to combat economic exploitation, as well  
9 as physical and mental abuse suffered by these workers at the hands of  
10 unethical employers; and

11 WHEREAS, The Instituto works closely with community-based  
12 organizations, federal and state agencies, law firms, and labor unions to  
13 ensure that all aspects of client issues are addressed; and,

14 WHEREAS, The Instituto provides Legal and Educational assistance as  
15 well as offering services in translation, research, and teaching of basic  
16 office skills; and,

17 WHEREAS, Legal assistance offered by the Instituto includes claims  
18 for back wages, unemployment insurance appeals, Workers' Compensation,  
19 unfair labor practices and immigration law related to employment; and,

20 WHEREAS, Educational assistance includes job readiness training,  
21 leadership training, workplace seminars, union rights, and job  
22 opportunities in organized labor; and,

23 WHEREAS, In June of 2000, after almost 2 decades of securing a  
24 presence in San Francisco's Mission District, the Instituto expanded their  
25 services to the East Bay with the Grand Opening of their Oakland office;  
now, therefore be it

1           RESOLVED, That the Board of Supervisors of the City and County of San  
2 Francisco hereby commends the Instituto Laboral de la Raza for their  
3 commitment to protecting workers' rights as well as their dedication to  
4 ensuring that social and economic needs are met within the Latino  
5 community.
