6 WHEREAS, Project Read provides professionally trained volunteers who offer free,
7 one-on-one tutoring to adults who want to improve their basic English language reading and
8 writing skills; and

9 WHEREAS, since its founding in 1983, Project Read has assisted some 6,000 adult
10 learners in San Francisco to improve their reading and writing skills, and now provides access
11 to 21st Century skills in the Project Read Computer Lab, thus setting these learners on the
12 paths to future success; and

13 WHEREAS, in its 30 year history, Project Read has developed a model, motivational
14 literacy program that ensures adult learners set goals for their learning based on their own
15 interests. These goals are reviewed every six months giving learners confidence by reviewing
16 their improvements and celebrating their achievements; and

17 WHEREAS, Project Read has expanded beyond its general literacy efforts and also
18 developed additional innovative programs such as Family Literacy Services to break the
19 intergenerational cycle of illiteracy Project Money, a learner driven approach to financial
20 literacy; and the Wednesday Night Readers, a Project Read book club that promotes the joy
21 of reading to new readers; and

22 WHEREAS, the City and County of San Francisco is pleased to recognize and honor
23 the dedicated staff, volunteers and supporters who sustain the important work of Project
24 Read, the adult literacy program of the San Francisco Public Library; now, therefore, be it
