3 **Resolution determining that the issuance of a Type 48 on-sale general public**
4 **premises license to Destination Bars, Inc. for The Lark located at 29-3rd Street**
5 **(District 6), will serve the public convenience or necessity of the City and County**
6 **of San Francisco in accordance with California Business and Professions Code,**
7 **Section 23958.4, and recommending that the California Department of Alcoholic**
8 **Beverage Control impose conditions on the issuance of the license.**

10 WHEREAS, Destination Bars, Inc. is seeking the issuance of a Type 48 on-sale
11 general public premises license for The Lark located at 29-3rd Street (District 6); and

12 WHEREAS, The Planning Department has verified that the area is properly
13 zoned and recommends approval; and

14 WHEREAS, The Police Department has filed zero (0) protests with the
15 Department of Alcoholic Beverage Control under California Business and Professions
16 Code, Section 24013, and recommends that the Department of Alcoholic Beverage
17 Control issue the liquor license with conditions; and

18 WHEREAS, The conditions recommended by the Police Department, as
19 amended, are the following: 1) sales of alcoholic beverages shall be permitted between
20 the hours of 9:00 a.m. to 2:00 a.m. each day of the week; 2) the sale of alcoholic
21 beverages for off-sale consumption is strictly prohibited; now, therefore, be it

22 **RESOLVED, That in accordance with California Business and Professions Code,**
23 **Section 23958.4, the Board of Supervisors of the City and County of San Francisco**
24 **hereby determines that the issuance of a Type 48 on-sale general public premises**
25 **license to Destination Bars, Inc. for The Lark located at 29-3rd Street (District 6), will**

1 serve the public convenience or necessity of the City and County of San Francisco; and,

3 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
4 San Francisco hereby endorses and adopts the recommendations of the Police
5 Department listed above, and recommends that the Department of Alcoholic Beverage
6 Control issue the license with those conditions.
