9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Danielle Dillard et al. v. City and  
12 County of San Francisco et al, San Francisco Superior Court, Case No. CGC-20-585992, by  
13 the payment of \$2,800,000. The lawsuit involves an employment dispute.
