

1 [Appointment, Park, Recreation, and Open Space Advisory Committee - Patrick Roddy]

3 **Motion appointing Patrick Roddy (residency requirement waived), term ending**  
4 **February 1, 2022, to the Park, Recreation and Open Space Advisory Committee.**

6 MOVED, That the Board of Supervisors of the City and County of San Francisco does  
7 hereby appoint the hereinafter designated person to serve as a member of the Park,  
8 Recreation and Open Space Advisory Committee, pursuant to the provisions of Park Code,  
9 Article 13, and Charter, Section 16.107, for the term specified:

10 Patrick Roddy (residency requirement waived), Seat 17, succeeding Ana Teresa Gee,  
11 term expired, must be nominated by the District 6 Supervisor from the organizations listed in  
12 Resolution No. 391-13, for the unexpired portion of a two-year term ending February 1, 2022;  
13 and, be it

14 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 15 1. The membership of the Park, Recreation and Open Space Advisory Committee has a  
16 goal to be representative of the diversity of the City and County of San Francisco.
- 17 2. Applicant Patrick Roddy, who is not a resident of San Francisco, is a person with  
18 experience that uniquely qualifies them to serve on the Park, Recreation and Open  
19 Space Advisory Committee.
- 20 3. The Park, Recreation and Open Space Advisory Committee has attempted to fill the  
21 position, for which Patrick Roddy was nominated, with an individual who is City a  
22 resident and who has the specific experience, skills, and qualifications, but has been  
23 unable to do so at this time. The Rules Committee has certified that Patrick Roddy, is  
24 qualified to serve on the Park, Recreation and Open Space Advisory Committee.

1 4. After exercising due diligence, the Board of Supervisors concludes that there is no  
2 other possible representatives, who is a resident of San Francisco, and who has the  
3 specific experience, skills, or qualifications possessed by this applicant, and who is  
4 willing to serve on the Park, Recreation and Open Space Advisory Committee at this  
5 time; and, be it

6 FURTHER MOVED, That the Board of Supervisors waives the residency requirement  
7 for Patrick Roddy, as allowed in cases where no qualified City resident, willing to serve, can  
8 be found, pursuant to Charter, Section 4.101(a)(2), that requires person(s) appointed to  
9 boards, commissions, and advisory bodies established by legislative act of the Board of  
10 Supervisors to be resident(s) of the City and County of San Francisco.
