

1 [Accept-Expend Private Grant - National Trust for Historic Preservation Cynthia Woods  
2 Mitchell Fund for Historic Interiors Grant]

4 **Resolution authorizing the Arts Commission of the City and County of San Francisco**  
5 **to retroactively accept and expend a grant in the amount of \$5,000 from the Cynthia**  
6 **Woods Mitchell Fund for Historic Interiors (a fund of the National Trust for Historic**  
7 **Preservation) for the Bayview Opera House Renovation and Restoration Project.**

9 WHEREAS, The Bayview Opera House is undergoing the most significant renovation  
10 and restoration project in its history. This local historic landmark (built in 1888) must remain a  
11 vibrant contributor of programming and gathering point for cultural experiences for the  
12 Bayview Hunters Point community; and,

13 WHEREAS, This grant award will allow the first steps of the interior's renovation to  
14 begin and this is part of a large effort on behalf of the entire San Francisco family to restore  
15 the Bayview Opera House and surrounding plaza. The San Francisco Arts Commission  
16 serves to oversee all facility maintenance and repair of the Bayview Opera House; and,

17 WHEREAS, This grant does not create any new positions, and will not require an  
18 amendment to the Annual Salary Ordinance; and,

19 WHEREAS, That the Board of Supervisors hereby waives inclusion of indirect costs in  
20 the grant budget; and,

21 **RESOLVED,** That the Board of Supervisors hereby authorizes the Arts Commission of  
22 the City and County of San Francisco to accept and expend the \$5,000 match-fund on a one-  
23 to-one basis from the National Trust for Historic Preservation for its purpose. This grant  
24 period is from July 9, 2008 to July 9, 2009; and,

1 FURTHER RESOLVED, That the Arts Commission is authorized to execute on behalf  
2 of the City and County of San Francisco the necessary Grant Award Agreements for the  
3 purpose of overseeing maintenance of the Bayview Opera House; and,

4 FURTHER RESOLVED, That the Arts Commission is to implement and carry out the  
5 purposes specified in the applicable grant application and provide all procurement of goods  
6 and services, and maintain auditable records of all expenditures; and,

7 FURTHER RESOLVED, That this historic buildings restoration will serve for continued  
8 neighborhood revitalization and increased community engagement and have a positive impact  
9 on this critical intersection. The Bayview Opera House revitalization has been a city priority for  
10 years.




