

1 [Liquor License Transfer - 5601 Geary Boulevard]

3 **Resolution determining that the transfer of a Type 20 off-sale beer and wine**
4 **license to Mainland Market Co., dba Mainland Market Co., located at 5601 Geary**
5 **Boulevard (District 1), will serve the public convenience or necessity of the City**
6 **and County of San Francisco in accordance with California Business and**
7 **Professions Code, Section 23958.4, and recommending that the California**
8 **Department of Alcoholic Beverage Control impose conditions on the issuance of**
9 **the license.**

11 WHEREAS, Mainland Market Co. is seeking the transfer of a Type 20 off-sale
12 beer and wine license dba Mainland Market Co. located at 5601 Geary Boulevard
13 (District 1); and

14 WHEREAS, The Planning Department has verified that the area is properly
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed one (1) protests with the
17 Department of Alcoholic Beverage Control under California Business and Professions
18 Code, Section 24013, and recommends that the Department of Alcoholic Beverage
19 Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the
21 following: 1) Sales of alcoholic beverages shall be permitted between the hours of 7:00
22 a.m. to 10:00 p.m. each day of the week; 2) no beer or malt beverages shall be sold in
23 quantities of less than manufacturer pre-packaged six packs per sale with the exception
24 of wine-coolers, beer coolers which must be sold in manufacturer pre-packaged multi-
25 unit quantities of four (4) or more; 3) no wine shall be sold with an alcoholic content of

1 greater than 15% by volume except for “Dinner Wines” which have been aged two years
2 or more and maintained in corked bottles; and 4) loitering (defined as “to stand idly
3 about; linger aimlessly without lawful business”) is prohibited on any sidewalks or
4 property adjacent to the licensed premises under the control of the licensee; now,
5 therefore, be it

6 RESOLVED, That in accordance with California Business and Professions Code,
7 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
8 hereby determines that the transfer of a Type 20 off-sale beer and wine license to
9 Mainland Market Co. dba Mainland Market Co., located at 5601 Geary Boulevard
10 (District 1), will serve the public convenience or necessity of the City and County of San
11 Francisco; and, be it

12 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
13 San Francisco hereby endorses and adopts the recommendations of the Police
14 Department listed above and recommends that the Department of Alcoholic Beverage
15 Control issue the license with those conditions.
