3 **Resolution Authorizing the Chief of Police for the City and County of San Francisco to**
4 **retroactively accept and expend a grant in the amount of \$65,000.00 (Sixty-Five**
5 **Thousand dollars) from the California Department of Boating and Waterways to**
6 **purchase miscellaneous boating equipment for use in boating safety and law**
7 **enforcement activities.**

9 WHEREAS, The Chief of Police of the City and County of San Francisco desires to
10 participate in a program designated "Boating Safety and Enforcement Equipment Grant"
11 funded from funds made available through the California Department of Boating and
12 Waterways to provide financial aid for law enforcement agencies having a boating and safety
13 unit, and

14 WHEREAS, benefits provided through this State Program will enable the Police
15 Department to more effectively enforce laws and promote boating safety; and,

16 WHEREAS, the Chief of Police of the City and County of San Francisco is authorized
17 on behalf of the City and County of San Francisco to apply for retroactively, accept and
18 expend continued funding for this program from the California Department of Boating and
19 Waterways, and

20 WHEREAS the grant does not require an ASO amendment; and,

21 WHEREAS, The grant terms prohibit including indirect costs in the grant budget now,
22 therefore, be it

23 RESOLVED, That the Chief of Police of the City and County of San Francisco is
24 authorized to execute on behalf of the City and County of San Francisco the necessary Grant

2 augmentations from the California Department of Boating and Waterways; and be it

3 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
4 indirect costs in the grant budget; and be it

5 FURTHER RESOLVED, That the San Francisco Police Department shall be
6 responsible for the costs of operating and maintaining the patrol boat in good repair;
7 and be it

8 FURTHER RESOLVED, That the San Francisco Police Department at its own
9 expense, agrees to replace any grant funded purchases if it is destroyed or rendered useless
10 prior to the expiration of this contract; and be it

11 FURTHER RESOLVED, The California Department of Boating and Waterways shall be
12 the legal owner of this grant funded equipment and the San Francisco Police Department
13 shall be the registered owner and shall not assign, mortgage, hypothecate or transfer its
14 interest in the grant funded equipment without prior written approval of the California
15 Department of Boating and Waterways; and be it


16 FURTHER RESOLVED, that it is agreed that any liability arising out of the performance
17 of this Grant Award Agreement, including civil court actions for damages, shall be the
18 responsibility of the City and the San Francisco Police Department; and be it

19 FURTHER RESOLVED, that grant funds received hereunder shall not be used to
20 supplant expenditures controlled by this body.






