3 **Ordinance authorizing settlement of the lawsuit filed by Leticia Avila against the City**
4 **and County of San Francisco for \$275,000; the lawsuit was filed on December 4, 2019,**
5 **in San Francisco Superior Court, Case No. CGC-19-581286; entitled Leticia Avila vs.**
6 **City and County of San Francisco, Human Services Agency; the lawsuit involves an**
7 **employment dispute.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Leticia Avila vs. City and County of
12 San Francisco, Human Services Agency, San Francisco Superior Court, Case No. CGC-19-
13 581286 by the payment of \$275,000. This lawsuit involves an employment dispute.
