

1 [Approval of Additional Emergency Work.]

2  
3 **Resolution authorizing the Director of the Mayor's Office of Housing ("MOH") to take all**  
4 **necessary measures to protect the health and safety of the residents of Midtown Park**  
5 **Apartments by performing additional emergency repairs to the sewer systems and**  
6 **exterior staircases.**

8 WHEREAS, The City and County of San Francisco, a municipal corporation, is the  
9 owner of "Midtown Park Apartments" located at 1415 Scott Street, Lot 31, Assessor's Block  
10 1099, which real property is currently under the jurisdiction of MOH; and

11 WHEREAS, the City leases Midtown Park Apartments to the Midtown Park  
12 Corporation, a California nonprofit corporation; and

13 WHEREAS, the City is obligated, as the owner, to correct all extraordinary disrepairs;  
14 and

15 WHEREAS, the Director of MOH determined that the sewer system, which transports  
16 waste matter from the buildings, along with the potential failure of ten staircases poses a  
17 threat to the health and safety of residents; and

18 WHEREAS, following inspections and testing it was determined that the sewer  
19 system's broken and obsolete pipes must be repaired and/or replaced and the staircases  
20 rebuilt ;and

21 WHEREAS, the total estimated cost for this work is approximately \$2,745,513; and

22 WHEREAS, Midtown Park Apartments cannot fund the costs of these emergency  
23 repairs from the operating budget; and

24 WHEREAS, such rehabilitation and reconstruction is an eligible Community  
25 Development Activity; and

1           WHEREAS, MOH has prepared a budget for the use of these funds as shown in  
2 Addendum # A; now therefore be it

3           RESOLVED, that the Board of Supervisors does hereby authorize the Director of the  
4 Mayor's Office of Housing to expend federal housing funds to pay for all costs associated with  
5 issuing requests for proposals, accepting appropriate proposals and entering into contracts in  
6 order to perform emergency repairs at Midtown Park Apartments.
