7 WHEREAS, The Board of Supervisors is enacting a Electrical Code for the City and  
8 County of San Francisco to be known as the "2001 San Francisco Electrical Code"; and

9 WHEREAS, The aforesaid San Francisco Electrical Code differs in part from the State  
10 Electrical Code for buildings; and

11 WHEREAS, California Health and Safety Code Section 17958.5 requires the City to  
12 furnish to the California Building Standards Commission reasons for amending the State  
13 Electrical code based upon local conditions; and,

14 WHEREAS, A specific section by section statement of the reasons for each  
15 amendment is set forth in that certain document in the Board of Supervisor's file No. 021204  
16 \_\_\_\_\_ identified therein and hereinafter referred to as Exhibit A; and

17 WHEREAS, The Board of Supervisors has reviewed the statement of reasons set forth  
18 for each amendment in said Exhibit A; and

19 WHEREAS, The Board of Supervisors finds and determines that these differences in  
20 the San Francisco Electrical Code are necessary because of local conditions for the reasons  
21 set forth in Exhibit A; now therefore be it

22 **RESOLVED**, That the Board of Supervisors does hereby find and determine that  
23 the aforesaid changes to the San Francisco Electrical Code are necessary because of local  
24 conditions for the reasons set forth in Exhibit A; and be it




