Good Afternoon:

The Board of Supervisors' Rules Committee (a nonfiscal committee) amended the following legislation on May 24, 2025. Pursuant to Administrative Code, Section 2.6-3, the new version is being forwarded to you since it was initially determined not to have fiscal impact, but the amendments made were substantive and another review for a fiscal impact determination is required. File No. 241209 (Ver2)

Ordinance amending the Administrative Code to change the Annual Economic Statement of City-Funded Organizations requirements to limit the application of nonprofit reporting requirements to organizations receiving more than \$1,000,000 annually, reduce required information types, and permit redaction of information to avoid personal harm.

If the new version is determined to have fiscal impact, the legislation will need to be referred to a fiscal committee before it can be referred to the full Board for approval.
