 7 **Metal and Glass Workers, Local Union No. 718; International Alliance of Theatrical**  
 8 **Stage Employees, Moving Picture Technicians, Artist and Allied Crafts of the United**  
 9 **States, Its Territories and Canada, Local 16; International Association of Bridge,**  
 10 **Structural, Ornamental, Reinforcing Iron Workers, Riggers and Machinery Movers,**  
 11 **Local 377; Plasterers and Shophands, Local 66; United Union of Roofers,**  
 12 **Waterproofers and Allied Workers, Local 40; International Association of Sheet Metal,**  
 13 **Air, Rail, and Transportation Workers, Sheet Metal Workers, Local Union No. 104; and**  
 14 **Teamsters, Local 853, to be effective July 1, 2024, through June 30, 2027.**

22 Be it ordained by the People of the City and County of San Francisco:

23 Section 1. The Board of Supervisors hereby adopts and implements the Memorandum  
 24 of Understanding (“MOU”) between the City and County of San Francisco and the Crafts  
 25 Coalition: the Bricklayers and Allied Crafts, Local 3; Hod Carriers of LIUNA, Local 261;  
 Carpet, Linoleum and Soft Tile Workers, Local 12; Plasterers and Cement Masons, Local 300;

1 Glaziers, Architectural Metal and Glass Workers, Local Union No. 718; International Alliance  
2 of Theatrical Stage Employees, Moving Picture Technicians, Artist and Allied Crafts of the  
3 United States, Its Territories and Canada, Local 16; International Association of Bridge,  
4 Structural, Ornamental, Reinforcing Iron Workers, Riggers and Machinery Movers, Local 377;  
5 Plasterers and Shophands, Local 66; United Union of Roofers, Waterproofers and Allied  
6 Workers, Local 40; International Association of Sheet Metal, Air, Rail, and Transportation  
7 Workers, Sheet Metal Workers, Local Union No. 104; and Teamsters, Local 853, to be  
8 effective July 1, 2024 through June 30, 2027.

9 The MOU so implemented is on file with the Clerk of the Board of Supervisors in Board  
10 File No. 240516.

11  
12 Section 2. The Board of Supervisors hereby authorizes the Department of Human  
13 Resources to make non-substantive ministerial or administrative corrections to the MOU.

14  
15 Section 3. Effective Date. This ordinance shall become effective upon enactment.  
16 Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance  
17 unsigned or does not sign the ordinance within ten days of receiving it, or the Board of  
18 Supervisors overrides the Mayor's veto of the ordinance.
