12 WHEREAS, The City and County of San Francisco approved the modification of the  
13 contract with the IHSS Consortium of San Francisco, on file with the Clerk of the Board of  
14 Supervisors in File No. 02-0052, which is hereby declared to be a part of this resolution as if  
15 set forth fully herein; and,

16 WHEREAS, The California Welfare and Institution Code, Section 12302.1, subdivision  
17 (a) allows counties to renew IHSS contracts for a second term not to exceed one year; and,

18 WHEREAS, The Human Services Commission will consider the approval of the  
19 renewal contract with the IHSS Consortium of San Francisco at its meeting of May 13, 2004;  
20 now, therefore, be it

21 RESOLVED, That the Board of Supervisors hereby approves the exercise of the option  
22 to renew this contract with the IHSS Consortium of San Francisco, for the period of July 1,  
23 2004 to June 30, 2005, in the amount of \$16,085,136.




