12 WHEREAS, The National Trust for Historical Preservation has been delegated the
13 responsibility for the administration of the Partners in Preservation Grant Program and the
14 grant Project shown above, setting up necessary procedures; and,

15 WHEREAS, The Applicant will enter into a contract with the National Trust for Historical
16 Preservation for the Project; and,

17 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now,
18 therefore, be it

19 RESOLVED, That the City and County of San Francisco hereby approves the
20 acceptance and expenditure of a grant in the amount of \$75,000 for the Golden Gate Park
21 Spreckels Temple of Music Restoration awarded by the American Express Partners in
22 Preservation Grant Program administered by the National Trust for Historical Preservation;

24 FURTHER RESOLVED, That the City and County of San Francisco waives inclusion of
25 indirect costs in the grant budget; and, be it


