3 **Resolution urging the Executive Committee of the Pacifica National Board to cease**  
4 **efforts which undermine KPFA's content and programming, democratically restructure**  
5 **the Pacifica Radio Network, and demand that Pacifica guarantee in writing that KPFA**  
6 **will not be sold without the overwhelming approval and consent of KPFA's**  
7 **subscribers, supporters and staff.**

9 WHEREAS, KPFA Radio Station plays an outstanding role in providing crucial  
10 community radio services for the San Francisco Bay Area; and,

11 WHEREAS, the station has for more than fifty years has provided a forum for a host of  
12 political movements, including protecting First Amendment Right of Free Speech, to the civil  
13 rights movement, the anti-war movement, and the gay and lesbian rights movement; and,

14 WHEREAS, KPFA has been a crucial cultural force, promoting everything from avant-  
15 garde classical music, Jazz, World Music, and radio drama; and,

16 WHEREAS, KPFA has given voice to tens of thousands of diverse individuals and  
17 groups throughout the Bay Area who would never be heard otherwise; and,

18 WHEREAS, KPFA's parent organization, the Pacifica Foundation, has since 1999  
19 taken an increasingly aggressive stance towards the station, including terminating without  
20 process its general manager and best on-air staff, expelling KPFA's staff from their own  
21 building and then arresting them, entertaining proposals to sell KPFA; and,

22 WHEREAS, members of the Pacifica Foundation's Board of Directors are now  
23 proposing undemocratic by-laws that would enable the Executive Committee of the Board to  
24 sell KPFA; and,


