Section 1. Division III of Article 26 of the San Francisco Health Code is hereby amended by amending Sections 1615 and 1616, to read as follows:

SEC. 1615. TAX COLLECTOR TO SEND INFORMATION WITH PROPERTY TAX BILLS. (a) The Tax Collector shall mail a copy of the Informational Bulletin or an equivalent lead hazard warning, along with each County tax bill.

(b) The Tax Collector shall mail a copy of the Pre-1978 Hazard Notice and Affidavit forms prepared under Section 1610 along with each County tax bill until January 1, ((2000)) 2003.

SEC. 1616. BUILDING OWNERS TO PROVIDE PROOF OF NOTICE. Every owner of any dwelling unit constructed prior to 1978 shall provide a copy of the Pre-1978 Hazard Notice, and any other form of notice required by federal or State law to every tenant in each such dwelling unit within 10 days of commencement of occupancy, or for tenancies in existence on the effective date of this Article, within 60 days of such effective date. The owner shall complete, sign and maintain Affidavits provided in Section 1610(c) as instructed thereon in order to provide evidence of compliance with this Article. The requirements of this Section

1	shall terminate effective January 1, ((2000)) 2003.
