3 Resolution authorizing the San Francisco Department of Public Health (DPH) to accept
4 and expend retroactively a grant in the amount of \$7,360 from the University of
5 California, Berkeley for a project entitled "Worker Health and Safety in Chinatown
6 Restaurants," for the period of September 1, 2007 through August 31, 2008.

8 WHEREAS, University of California , Berkeley (UCB) is the recipient of a grant from the
9 Centers for Disease Control – National Institute for Occupational Safety and Health to fund a
10 project entitled "Worker Health and Safety in Chinatown Restaurants: A CBPR Study;" and,

11 WHEREAS, UCB has agreed to fund DPH's Environmental Health Section (EHS) in
12 the amount of \$7,360 to participate in this project, for the period of September 1, 2007 through
13 August 31, 2008; and,

14 WHEREAS, UCB intends to fund DPH for a second year based upon successful
15 completion of the first, in the amount of \$7,580 for the period of September 1, 2008 through
16 August 31, 2009, for a two year total of \$14,940; and,

17 WHEREAS, These funds will allow DPH-EHS to collaborate with the Chinese
18 Progressive Association, the School of Public Health/Labor Occupational Program at UCB,
19 and the Department of Occupational medicine at UCSF to investigate Chinatown worker
20 health and safety; and,

21 WHEREAS, An ASO amendment is not required as the grant partially reimburses DPH
22 for one existing position, Health Program Coordinator I (Job Class #2589) at .07 FTE, for the
23 period of September 1, 2007 through August 31, 2008; and,

7 amount of \$7,360, for the period of September 1, 2007 through August 31, 2008; and, be it


8 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
