

1 [Amending Declaration of November 2, 2004 Election Results.]

3 **Resolution amending Resolution No, 735-04, which declared the results of the**  
4 **November 2, 2004 Consolidated General Election, to include results of uncontested**  
5 **races.**

6 WHEREAS, On December 7, 2004, the Board of Supervisors adopted Resolution No.  
7 735-04, which declared the results of the Consolidated General Election conducted in the City  
8 and County of San Francisco on Tuesday, November 2, 2004; and

9 WHEREAS, Resolution no. 735-04 included results of election contests for the San  
10 Francisco Board of Supervisors, the Governing Board of the Community College District, the  
11 Governing Board of the San Francisco Unified School District, and fifteen City and County  
12 ballot measures, but did not include the results of uncontested judicial races and an  
13 uncontested race for Bay Area Rapid Transit (BART) District Board of Directors; and

14 WHEREAS, Under California Elections Code Section 8203, when the only candidate to  
15 file nomination papers for the office of superior court judge is the incumbent, and there is no  
16 qualified write-in candidate seeking election to that office, the office does not appear on the  
17 ballot; and

18 WHEREAS, Under California Elections Code Section 10515, when only one candidate  
19 files nomination papers for election to a seat on the BART District Board of Directors, and  
20 there is no qualified write-in candidate seeking election to that seat, the office does not appear  
21 on the ballot; now, therefore, be it

22 **RESOLVED**, That this Board of Supervisors amends Resolution No. 735-04, and  
23 declares, under Sections 8203, 9269 and 15400 of the California Elections Code, the results  
24 of the uncontested races in the Consolidated General Election conducted in the City and  
25 County of San Francisco on Tuesday, November 2, 2004, as previously certified by the

1 Director of Elections, as follows:


