2 AMENDING ARTICLE XIII, CHAPTER 10, PART I OF THE SAN FRANCISCO MUNICIPAL
3 CODE (ADMINISTRATIVE CODE) BY ADDING SECTION 10.117-123 THERETO,
4 ESTABLISHING THE STREET ARTISTS FUND AS A SPECIAL FUND FOR THE PURPOSE
5 OF RECEIVING ALL FUNDS RECEIVED BY THE SAN FRANCISCO ARTS COMMISSION
6 STREET ARTISTS PROGRAM PURSUANT TO ARTICLE 24 OF THE SAN FRANCISCO
7 POLICE CODE, AND PROVIDING FOR INTEREST ACCUMULATION THEREIN.

8 **NOTE: This entire section is new.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Chapter 10 of the San Francisco Administrative Code is hereby amended
12 by adding Section 10.117-123, to read as follows:

13 **SEC. 10.117-123. STREET ARTIST FUND.**

15 (a) **Establishment of Fund.** There is hereby established a special fund for the
16 purpose of receiving all fees received by the San Francisco Arts Commission for
17 the Street Artists Program pursuant to Article 24 of the San Francisco Police
18 Code, sections 2400 – 2411 (Regulating Street Artists). Said special fund shall
19 be known and designated as the "Street Artist Fund."
- 20 (b) **Acceptance of Gifts.** All donations of money and other gifts which may be
21 offered to the San Francisco Arts Commission for Street Artist Program
22 purposes are hereby accepted for such purposes. Any grants, gifts and
23 bequests from private sources for this purpose shall be deposited into said
24 special fund.

- 1 (c) **Existing Street Artists Fund.** The Controller shall cause all funds previously
2 received by the San Francisco Arts Commission pursuant to Article 24 of the
3 San Francisco Police Code, Sections 2400 – 2411 (Regulating Street Artists), to
4 be deposited into the Street Artist Fund established by this Section.
- 5 (d) **Expenditure of Monies.** The monies in this fund shall be expended, in
6 accordance with the budgetary and fiscal provisions of the Charter, solely for the
7 purposes of supporting the operation of the San Francisco Street Artists
8 Program.
- 9 (e) **Interest.** Interest shall be credited by the Controller on any balance of funds
10 accumulated in excess of \$50,000 remaining in said fund at the close of any
mlr 11 ~~business day~~. Interest earned from the Street Artist Fund shall become part of
12 the principal thereof, and shall not be expended for any purpose other than that
13 for which said fund is established.
- 14 (f) **Accumulation of Monies in Fund.** The balance remaining in the Street Artist
15 Fund at the close of any fiscal year shall be deemed to have been provided for a
16 specific purpose within the meaning of the Charter and shall be carried forward
17 and accumulated in said fund for the purposes recited herein.




