13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. The Administrative Code is hereby amended by amending Section 10.100-  
15 166 to read as follows:

16 **SEC. 10.100-166. PLANNING CODE ENFORCEMENT FUND.**

17 (a) **Establishment of Fund.** The Planning Code Enforcement Fund is established as a  
18 category four fund to receive funds collected ~~, pursuant to Section 610 of the Planning Code,~~ for  
19 penalties and fees assessed for violations of Planning Code requirements and regulations.  
20 ~~governing general advertising signs.~~

21 (b) **Use of Fund.** Proceeds in the fund are to be expended as follows: (i) administration  
22 and enforcement of the Planning Code's ~~sign~~ requirements and regulations, including but not  
23 limited to funding Planning Department personnel assigned to work on administration and  
24 enforcement of ~~sign~~ Planning Code requirements and regulations, and the services of the City  
25 Attorney; (ii) to the extent authorized by state law, penalties and fees collected by the City  
26 Attorney in any action to abate violations of the Planning Code's ~~sign~~ requirements and

1 regulations shall be used to fund administration and enforcement of the sign requirements and  
2 regulations, including the services of the City Attorney.

3  
4 Section 2. Effective Date. This ordinance shall become effective 30 days after  
5 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
6 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
7 of Supervisors overrides the Mayor's veto of the ordinance.

8  
9 Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors  
10 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,  
11 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal  
12 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment  
13 additions, and Board amendment deletions in accordance with the "Note" that appears under  
14 the official title of the ordinance.


