3 **Ordinance amending the Planning Code to correct errors, reenact previously-existing**
 4 **language that was repealed in error as part of the Article 2 Reorganization Ordinance,**
 5 **update the Code, and make nonsubstantive language revisions to simplify and clarify**
 6 **text; affirming the Planning Department’s determination under the California**
 7 **Environmental Quality Act; and making findings of consistency with the General Plan,**
 8 **and the eight priority policies of Planning Code, Section 101.1.**

14 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. Findings.

16 (a) The Planning Department has determined that the actions contemplated in this
 17 ordinance are not defined as a project under the California Environmental Quality Act (Public
 18 Resources Code Sections 21000 et seq.) and Sections 15050(c) and 15378 of the California
 19 Environmental Quality Act Guidelines, because they do not result in a physical change to the
 20 environment. Said determination is on file with the Clerk of the Board of Supervisors in File
 21 No. _____ and is incorporated herein by reference. The Board affirms this determination.

22 (b) On July 16, 2015, in Resolution No. 19420, the Planning Commission initiated this
 23 ordinance after conducting a duly noticed public hearing. A copy of Resolution No. 19420 is
 24 on file with the Clerk of the Board of Supervisors in File No. _____, and is incorporated
 25 herein by reference.

1 (c) On August 13, 2015, the Planning Commission, after conducting a duly noticed
2 public hearing, adopted Resolution No. 19433 recommending that the Board of Supervisors
3 approve the proposed amendments to the Planning Code. A copy of Resolution No. 19433 is
4 on file with the Clerk of the Board of Supervisors in File No. _____, and is incorporated
5 herein by reference.

6 (d) In Resolution No. 19433, the Planning Commission adopted findings that the
7 actions contemplated in this ordinance are consistent, on balance, with the City's General
8 Plan and eight priority policies of Planning Code Section 101.1. The Board adopts these
9 findings as its own.

10 (c) Pursuant to Planning Code Section 302, this Board finds that these Planning Code
11 amendments will serve the public necessity, convenience, and welfare for the reasons set
12 forth in Planning Commission Resolution Nos. 19420 and 19433 and the Board incorporates
13 such reasons herein by reference.

1 **SEC. 101. PURPOSES.**

2 This ~~City~~ Planning Code is adopted to promote and protect the public health, safety,
3 peace, morals, comfort, convenience and general welfare, and for the following more
4 particularly specified purposes:

5 (a) To guide, control and regulate future growth and development in accordance with
6 the General Master Plan of the City and County of San Francisco;

7 * * * *

8 **SEC. 101.1. GENERAL MASTER PLAN CONSISTENCY AND IMPLEMENTATION.**

9 (a) The General Master Plan shall be an integrated, internally consistent and compatible
10 statement of policies for San Francisco. To fulfill this requirement, after extensive public
11 participation and hearings, the ~~City~~ Planning Commission shall in one action amend the
12 General Master Plan by January 1, 1988.

13 (b) The following Priority Policies are hereby established. They shall be included in the
14 preamble to the General Master Plan and shall be the basis upon which inconsistencies in the
15 General Master Plan are resolved:

16 * * * *

17 (d) The City may not adopt any zoning ordinance or development agreement
18 authorized pursuant to Government Code Section 65865 after January 1, 1988, unless prior to
19 that adoption it has specifically found that the ordinance or development agreement is
20 consistent with the ~~City's~~ General Master Plan.

21 (e) Prior to issuing a permit for any project or adopting any legislation which requires an
22 initial study under the California Environmental Quality Act, and prior to issuing a permit for
23 any demolition, conversion or change of use, and prior to taking any action which requires a
24 finding of consistency with the General Master Plan, the City shall find that the proposed
25 project or legislation is consistent with the Priority Policies established above. For any such

1 permit issued or legislation adopted after January 1, 1988 the City shall also find that the
2 project is consistent with the *City's General Master* Plan.

3 **SEC. 102. DEFINITIONS.**

4 * * * *

5 **Automotive Service.** A subgrouping of Retail Automotive Uses providing services for motor
6 vehicles that includes ~~Automotive~~ Gas Station, Automotive Service Station, Automotive Repair,
7 and Automotive Wash.

8 **Automotive Service Station.** A Retail Automotive Use that provides motor fuels and
9 lubricating oils directly into motor vehicles and minor auto repairs (excluding engine repair,
10 rebuilding, or installation of power train components, reconditioning of badly worn or damaged
11 motor vehicles, collision service, or full body paint spraying) and services that remain
12 incidental to the principal sale of motor fuel. Repairs shall be conducted within no more than
13 three enclosed service bays in buildings having no openings, other than fixed windows or
14 exits required by law, located within 50 feet of any R District. It may include other incidental
15 services for automobiles including, but not limited to, accessory towing, if the number of
16 towing vehicles does not exceed one, and all towed vehicles stored on the premises are
17 limited to those vehicles that are to be repaired on the premises. *This use is subject to the*
18 *controls in Sections 187.1, 202.2(b), and 202.5.*

19 * * * *

20 **Bar.** A Retail Sales and Service Use that provides on-site alcoholic beverage sales for
21 drinking on the premises, including bars serving beer, wine and/or liquor to the customer
22 where no person under 21 years of age is admitted (with Alcoholic Beverage Control [ABC]
23 license types 23, 42, 48, or 61) and drinking establishments serving beer where minors are
24 present (with ABC license types ~~42~~ 40 or 60) in conjunction with other uses such as Movie
25

1 Theaters and General Entertainment. Such businesses shall operate with the specified
2 conditions in Section 202.2(a).

3 * * * *

4 **Gas Station.** A Retail Automotive Use that provides motor fuels, lubricating oils, air, and
5 water directly into motor vehicles and without providing ~~a~~Automotive ~~r~~Repair services, and
6 which also includes self-service operations that sell motor fuel only. This use is subject to the
7 controls in Sections 202.2(b); and 187.1; ~~and 228.~~

8 * * * *

9 **Grocery, General.** A Retail Sales and Services Use that:

11 (e) May have a Limited Restaurant use within the accessory use limits as set forth in
12 Section 703.2(b)(1)(C)(iii).

13 ~~(f)~~ Such businesses shall operate with the specified conditions in Section 202.2(a)(1)
14 ~~703.5.~~

15 (f) Requires Conditional Use authorization for conversion of a General Grocery use greater
16 than 5,000 square feet, pursuant to Section 202.3.

17 **Grocery, Specialty.** A Retail Sales and Services Use that:

19 (e) May provide Limited Restaurant services within the accessory use limits as set forth
20 in Section 703.2(b)(1)(C)(iii).

21 ~~(f)~~ Such businesses shall operate with the specified conditions in Section 202.2(a)(1)
22 ~~703.5.~~

24 **Hospital.** An Institutional Healthcare Use that includes a hospital, medical center, or other
25 medical institution that provides facilities for inpatient ~~and~~ or outpatient medical care and may

1 also include medical offices, clinics, laboratories, and employee or student dormitories and
2 other housing, operated by and affiliated with the institution, which institution has met the
3 applicable provisions of Section 304.5 of this Code concerning ~~i~~Institutional ~~m~~Master ~~p~~Plans.

5 **Restaurant.** A Retail Sales and Service ~~U~~use that serves prepared, ready-to-eat cooked
6 foods to customers for consumption on or off the premises and which has seating. It may
7 have a Take-Out Food use ~~as defined by Planning Code Section 790.122~~ as a minor and
8 incidental use. It may provide on-site beer, wine, and/or liquor sales for drinking on the
9 premises (with ABC license types 41, 47, 49, 59, or 75); however, if it does so, it shall be
10 required to operate as a Bona Fide Eating Place ~~as defined in Section 790.142~~. It is distinct and
11 separate from a Limited-Restaurant. Such businesses shall operate with the specified
12 conditions in Section 202.2(a)(1).

13 It shall not be required to operate within an enclosed building ~~pursuant to Section~~
14 ~~703.2(b)(1)~~ so long as it is also a Mobile Food Facility ~~as defined in Section 102.34~~. Any
15 associated outdoor seating and/or dining area is subject to regulation as an Outdoor Activity
16 Area as set forth elsewhere in this Code.

20 **SEC. 103. HOUSING BALANCE MONITORING AND REPORTING.**

21 * * * *

22 **(b) Findings.**

23 * * * *

24 (6) In 2012, the City enacted Ordinance 237-12, the "Housing Preservation and
25 Production Ordinance," codified in Administrative Code ~~Section Chapter~~ 10E.4, to require

1 Planning Department staff to regularly report data on progress toward meeting San
2 Francisco's quantified production goals for different household income levels as provided in
3 the General Plan's Housing Element. That Ordinance requires data on the number of units in
4 all stages ~~of the~~ of the housing production process at various affordability levels to be included
5 in staff reports on all proposed projects of five ~~#~~Residential ~~#~~Units or more and in quarterly
6 housing production reports to the Planning Commission. The Planning Department has long
7 tracked the number of affordable housing units and total number of housing units built
8 throughout the City and in specific areas and should be able to track the ratio called for in this
9 Section 103.

10 (7) As the private market has embarked upon, and government officials have
11 urged, an ambitious program to produce significant amounts of new housing in the City, the
12 limited remaining available land makes it essential to assess the impact ~~of the~~ of the approval
13 of new market rate housing developments on the availability of land for affordable housing
14 and to encourage the deployment of resources to provide such housing. * * * *

15 (d) **Bi-annual Housing Balance Reports.** By June 1, 2015, the Planning Department
16 shall calculate the Cumulative and Projected Housing Balance for the most recent two
17 quarters City-wide, by Supervisorial District, Plan Area, and by neighborhood Planning
18 Districts, as defined in the annual Housing Inventory, and publish it as an easily visible and
19 accessible page devoted to Housing Balance and Monitoring and Reporting on the Planning
20 Department's website. By September 1st and March 1st of each year, the Planning
21 Department shall publish and update the Housing Balance Report, and present this report at
22 an informational hearing to the Planning Commission and Board of Supervisors, as well as to
23 any relevant body with geographic purview over a plan area upon request, along with the
24 other quarterly reporting requirements of Administrative Code Section ~~Chapter~~ 10E.4. The
25 annual report to the Board of Supervisors shall be accepted by resolution of the Board, which

1 resolution shall be introduced by the Planning Department. The Housing Balance Report shall
2 also be incorporated into the Annual Planning Commission Housing Hearing and Annual
3 Report to the Board of Supervisors required in Administrative Code ~~Section Chapter~~ 10E.4.

5 **SEC. 121. MINIMUM LOT WIDTH AND AREA.**

6 * * * *

7 (b) **Subdivisions and Lot Splits.** Subdivisions and lot splits shall be governed by the
8 Subdivision Code of the City and County of San Francisco and by the Subdivision Map Act of
9 California. In all such cases the procedures and requirements of said Code and said Act shall
10 be followed, including the requirement for consistency with the ~~General Master~~ Plan of the City
11 and County of San Francisco. Where the predominant pattern of residential development in
12 the immediate vicinity exceeds the minimum standard for lot width or area, or the minimum
13 standards for both lot width and area, set forth below in this Section, any new lot created by a
14 subdivision or lot split under the Subdivision Code shall conform to the greater established
15 standards, provided that in no case shall the required lot width be more than 33 feet or the
16 required lot area be more than 4,000 square feet.

18 **SEC. 121.2. USE SIZE LIMITS (NON-RESIDENTIAL), NEIGHBORHOOD COMMERCIAL**
19 **DISTRICTS.**

20 (a) In order to protect and maintain a scale of development appropriate to each district,
21 ~~Non-Residential~~ ~~Uses~~ of the same size or larger than the square footage stated in the table
22 below may be permitted only as conditional uses subject to the provisions set forth in Sections
23 316 through 316.86 of this Code. The use area shall be measured as the ~~Gross~~ ~~Floor~~ ~~Area~~
24 for each individual ~~Non-Residential~~ ~~Use~~.

SEC. 121.7. RESTRICTION OF LOT MERGERS IN CERTAIN DISTRICTS AND ON PEDESTRIAN-ORIENTED STREETS.

In order to promote, protect, and maintain a fine-grain scale of development in residential districts and on important pedestrian-oriented commercial streets which is appropriate to each district, compatible with adjacent buildings; provide for a diverse streetscape; ensure the maintenance and creation of multiple unique buildings and building frontages rather than large single structures superficially treated; promote diversity and multiplicity of land ownership and discourage consolidation of property under single ownership, merger of lots ~~are~~ is regulated as follows:

SEC. 124. BASIC FLOOR AREA RATIO.

(a) Except as provided in Subsections (b), (c), (d), (e) and (l) of this Section, the basic ~~f~~Floor ~~a~~Area ~~r~~Ratio limits specified in the Zoning Control Table for the district in which the lot is located, or in Table 124 below, shall apply to each building or development in the districts indicated.

**SEC. 132. FRONT SETBACK AREAS, RTO, RH AND RM DISTRICTS AND FOR
REQUIRED SETBACKS FOR PLANNED UNIT DEVELOPMENTS.**

* * * *

1 (g) **Landscaping and Permeable Surfaces.** The landscaping and permeable surface
2 requirements of this Section and Section (h) below shall be met by the permittee in the case
3 of construction of a new building; the addition of a new ~~a~~Dwelling ~~#~~Unit, a garage, or
4 additional parking; or paving or repaving more than 200 square feet of the front setback. All
5 front setback areas required by this Section 132 shall be appropriately landscaped, meet any
6 applicable water use requirements of Administrative Code Chapter 63, and in every case not
7 less than 20 percent of the required setback area shall be and remain unpaved and devoted
8 to plant material, including the use of climate appropriate plant material as defined in Public
9 Works Code Section 802.1. For the purposes of this Section, permitted obstructions as
10 defined by Section 136(c)(6) chimneys, 136(c)(14) stairs, and 136(c)(~~26~~ 27) underground
11 garages shall be excluded from the front setback area used to calculate the required
12 landscape and permeable surface area. If the required setback area is entirely taken up by
13 one or more permitted obstructions, the Zoning Administrator may allow the installation of
14 sidewalk landscaping that is compliant with applicable water use requirements of Chapter 63
15 of the Administrative Code to satisfy the requirements of this ~~s~~section, subject to permit
16 approval from the Department of Public Works in accordance with Public Works Code Section
17 810B.

19 **SEC. 134. REAR YARDS, R, NC, C, SPD, M, MUG, WMUG, MUO, MUR, UMU, RED, RED-**
20 **MX, RSD, SLR, SLI AND SSO DISTRICTS.**

21 The rear yard requirements established by this Section 134 shall apply to every
22 building in *an R, NC-1, NC-2 District or Individual Neighborhood Commercial District as noted in*
23 *Subsection (a), except those buildings which contain only single room occupancy (SRO) or live/work*
24 *units and except in the Bernal Heights Special Use District, Western SoMa Special Use District, and*
25 *Residential Character Districts to the extent these provisions are inconsistent with the requirements set*

1 ~~forth in Sections 242 and 823 of this Code. With the exception of dwellings in the South of Market~~
2 ~~Mixed Use and Eastern Neighborhoods Mixed Use Districts containing only SRO units, the rear yard~~
3 ~~requirements of this Section 134 shall also apply to every dwelling in a(n) MUG, WMUG, MUO, MUR,~~
4 ~~UMU, SPD, RED, RED-MX, RSD, SLR, SLI, SSO, NC-2, NCT-1, NCT-2, NC-3, NCT-3, Individual~~
5 ~~Area Neighborhood Commercial Transit District, Individual Neighborhood Commercial District as~~
6 ~~noted in Subsection (a), C or M District. Rear yards shall not be required in NC-S Districts. the~~
7 ~~districts listed below. To the extent that these provisions are inconsistent with any Special Use District~~
8 ~~or Residential Character District, the provisions of the Special Use District or Residential Character~~
9 ~~District shall apply.~~ These requirements are intended to assure the protection and continuation
10 of established midblock, landscaped open spaces, and maintenance of a scale of
11 development appropriate to each district, consistent with the location of adjacent buildings.

12 (a) **Basic Requirements.** The basic rear yard requirements shall be as follows for the
13 districts indicated:

14 (1) **RH-1(D), RH-1, RH-1(S), RM-3, RM-4, RC-1, RC-2, RC-3, RC-4, NC Districts**
15 **other than the Pacific Avenue NC District, C, M, MUG, WMUG, MUO, MUR, UMU, RED, RED-**
16 **MX, SPD, RSD, SLR, SLI and SSO Districts.** The minimum rear yard depth shall be equal to
17 25 percent of the total depth of the lot on which the building is situated, but in no case less
18 than 15 feet. For buildings containing only SRO ~~u~~Units in the South of Market Mixed Use and
19 Eastern Neighborhoods Mixed Use Districts, the minimum rear yard depth shall be equal to 25
20 percent of the total depth of the lot on which the building is situated, but the required rear yard
21 of SRO buildings not exceeding a height of 65 feet shall be reduced in specific situations as
22 described in Subsection (c) below.

24 (C) **RC-2, RC-3, RC-4, NC-3, NCT-3, Broadway, Hayes-Gough NCT,**
25 **Upper Market Street, Upper Market Street NCT, SoMa NCT, Mission Street NCT, Polk Street,**

1 **Pacific Avenue, C, M, SPD, RSD, SLR, SLI, SSO, MUR, MUG, MUO, and UMU Districts.**

2 Rear yards shall be provided at the lowest story containing a ~~d~~Dwelling ~~#~~Unit, and at each
3 succeeding level or story of the building. In the Hayes-Gough NCT, lots fronting the east side
4 of Octavia Boulevard between Linden and Market Streets (Central Freeway Parcels L, M, N,
5 R, S, T, U, and V) are not required to provide rear yards at any level of the building, provided
6 that the project fully meets the usable open space requirement for ~~d~~Dwelling ~~#~~Units per
7 Section 135 of this Code, the exposure requirements of Section 140, and gives adequate
8 architectural consideration to the light and air needs of adjacent buildings given the
9 constraints of the project site.

10 * * * *

11 (2) **RH-2, RH-3, RTO, RTO-M, RM-1 and RM-2 Districts, and the Pacific Avenue**
12 **NC District.** The minimum rear yard depth shall be equal to 45 percent of the total depth of the
13 lot on which the building is situated, except to the extent that a reduction in this requirement is
14 permitted by Subsection (c) below. Rear yards shall be provided at grade level and at each
15 succeeding level or story of the building.

17 (c) **Reduction of Requirements in RH-2, RH-3, RTO, RTO-M, RM-1 and RM-2**
18 **Districts.** The rear yard requirement stated in Paragraph (a)(2) above, ~~for RH-2, RH-3, RTO,~~
19 ~~RTO-M, RM-1 and RM-2 Districts,~~ and as stated in Paragraph (a)(1) above, ~~for single-room~~
20 ~~occupancy~~ SRO buildings located in either the South of Market Mixed Use or Eastern
21 Neighborhoods Mixed Use Districts not exceeding a height of 65 feet, shall be reduced in
22 specific situations as described in this Subsection (c), based upon conditions on adjacent lots.
23 Except for those SRO buildings referenced above in this paragraph whose rear yard can be
24 reduced in the circumstances described in Subsection (c) to a 15-foot minimum, under no
25 circumstances, shall the minimum rear yard be thus reduced to less than a depth equal to 25

1 percent of the total depth of the lot on which the building is situated, or to less than 15 feet,
 2 whichever is greater.

3 (1) **General Rule.** In such districts, the forward edge of the required rear yard
 4 shall be reduced to a line on the subject lot, parallel to the rear lot line of such lot, which is an
 5 average between the depths of the rear building walls of the two adjacent buildings. Except for

SEC. 137. MODIFICATION OF CERTAIN PLAZAS, ARCADES, AND SIDEWALKS.

In C-3 Districts, modifications and improvements of plazas, arcades, and/or sidewalks designed to make the spaces more attractive and useful may be approved, in accordance with the provisions of Section 309, by application of the standards contained in and the guidelines adopted pursuant to Section 138 and Section 138.1 of this Code and the objectives and policies of the Downtown Plan, a component of the General Master Plan, or any amendment thereto, notwithstanding the fact that such modifications and improvements would not have been permitted under former Sections 126(b)(5) and (b)(7) of this Code.

SEC. 138. PRIVATELY-OWNED PUBLIC OPEN SPACE REQUIREMENTS IN C-3 DISTRICTS.

(a) **Requirement.** An applicant for a permit to construct a new building or an addition of ~~g~~Gross ~~f~~Floor ~~a~~Area equal to 20 percent or more of an existing building (hereinafter "building") in C-3 Districts shall provide open space in the amount and in accordance with the standards set forth in this Section. All determinations concerning the adequacy of the amount of open space to be provided and its compliance with the requirements of this Section shall be made in accordance with the provisions of Section 309.

(b) **Amount Required.** Except in the C-3-O(SD) District, open space shall be provided in the amounts specified below for all uses except (i) ~~r~~Residential ~~u~~Uses, which shall be governed by Section 135 of this Code and (ii) ~~i~~Institutional ~~u~~Uses.

(b) Better Streets Plan.

(1) The Better Streets Plan, as defined in Administrative Code Section 98.1(e), shall govern the design, location, and dimensions of all pedestrian and streetscape items in the public right-of-way, including but not limited to those items shown in Table 1. Development projects that propose or are required through this ~~s~~Section to make pedestrian and streetscape improvements to the public right-of-way shall conform with the principles and guidelines for those elements as set forth in the Better Streets Plan to the maximum extent feasible.

(2) Proposed improvements also shall be subject to approval by other ~~e~~City bodies with permitting jurisdiction over such streetscape improvements.

SEC. 140. ALL DWELLING UNITS IN ALL USE DISTRICTS TO FACE ON AN OPEN AREA.

(a) **Requirements.** With the exception of *d*Dwelling #Units in *single room occupancy SRO* buildings in the South of Market Mixed Use Districts, in each *d*Dwelling #Unit in any use district, the required windows (as defined by Section 504 of the San Francisco Housing Code) of at least one room that meets the 120-square-foot minimum superficial floor area requirement of Section 503 of the Housing Code shall face directly on an open area of one of the following types:

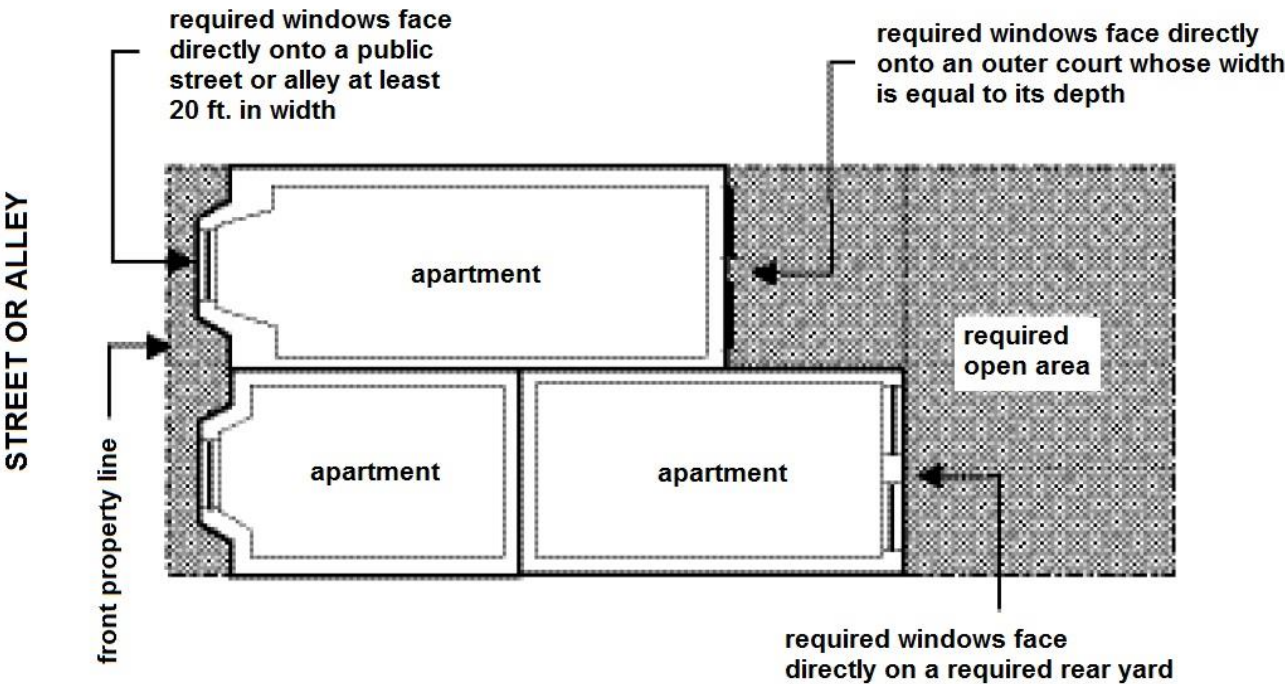
(1) A public street, public alley at least 20 feet in width, side yard at least 25 feet in width, or rear yard meeting the requirements of this Code; provided, that if such windows are on an outer court whose width is less than 25 feet, the depth of such court shall be no greater than its width; or

(2) An open area (whether an inner court or a space between separate buildings on the same lot) which is unobstructed (except for fire escapes not projecting more than necessary for safety and in no case more than four feet six inches, chimneys, and those obstructions permitted in Sections 136(c)(14), (15), (16), (19), (20) and (29) of this Code) and is no less than 25 feet in every horizontal dimension for the floor at which the *d*Dwelling #Unit

1 in question is located and the floor immediately above it, with an increase of five feet in every
2 horizontal dimension at each subsequent floor, except for ~~single room occupancy~~ SRO buildings
3 in the Eastern Neighborhoods Mixed Use Districts, which are not required to increase five feet
4 in every horizontal dimension until the fifth floor of the building.

5 (b) **Exceptions.** For historic buildings identified in Section 307(h), and for the
6 conversion of a nonconforming use in an existing building to a Residential Use in a district
7 where the Residential Use is principally permitted, the requirements of this Section 140 may
8 be modified or waived pursuant to the procedures and criteria set forth in Sections 307(h) and
9 329. This administrative exception does not apply to new additions to historic buildings.

SEC. 154. DIMENSIONS FOR OFF-STREET PARKING, FREIGHT LOADING AND SERVICE VEHICLE SPACES.

(a) **Parking Spaces.** Required parking spaces may be either independently accessible or space-efficient as described in 154(a)(4) and 154(a)(5), except as required elsewhere in the Building Code for spaces specifically designated for persons with physical disabilities. Space-efficient parking is encouraged.

(1) Each independently accessible off-street parking space shall have a minimum area of 144 square feet (8 feet by 18 feet) for a standard space and 112.5 square feet for a compact space (7.5 feet by 15 feet), except for the types of parking spaces authorized by Paragraph (a)(4) below and spaces specifically designated for persons with physical disabilities, the requirements for which are set forth in the Building Code. Every required space shall be of usable shape. The area of any such space shall be exclusive of driveways, aisles and maneuvering areas. The parking space requirements for the Bernal Heights Special Use District are set forth in Section 242.

14 (B) **Reduction of Ratio of Residential Uses for Affordable Housing.** The
15 Planning Commission may modify the Van Ness Special Use District residential to
16 nonresidential use ratio between Golden Gate Avenue and California Street as a conditional
17 use in one of the following ways:

19 (iii) **Annual Reporting, Evaluation, and Adjustments to Affordability**
20 **and Fee Calculations.** The Department shall report annually to the Planning Commission on
21 the activity and utilization of Section 243(c)(8)(B). Based on an evaluation of this report, the
22 Planning Commission may initiate a modification or deletion of Section 243(c)(8)(B). The
23 dollar amounts used in the calculation for Paragraphs (i) and (ii) of this Subsection shall be
24 subject to annual adjustments in accord with Section ~~413.6(1)~~ 409 of this Code. Affordability

1 shall be defined by rents or sale prices affordable by households with no more than 80
2 percent of median income standards developed by HUD.

4 **SEC. 244. RESIDENTIAL CHARACTER DISTRICTS.**

5 In order to provide for certain areas with special building forms and natural
6 characteristics, there shall be ~~R~~Residential ~~C~~Character ~~D~~Districts as designated on Special Use
7 Districts Sectional Maps of the Zoning Map. In these ~~R~~Residential ~~C~~Character ~~D~~Districts, all
8 provisions of the ~~City~~ Planning Code applicable to the underlying R (Residential) District shall
9 continue to apply to ~~R~~Residential ~~C~~Character ~~D~~Districts except as otherwise provided in the
10 sections for the specific districts which follow or as shown on the Zoning Map. A ~~R~~Residential
11 ~~C~~Character ~~D~~District may include residential design guidelines for that district, to supplement

13 ~~Planning~~, as amended from time to time.

14 **SEC. 244.1. WESTWOOD PARK RESIDENTIAL CHARACTER DISTRICT.**

15 The following provisions shall apply within the Westwood Park Residential Character
16 District:

17 ~~(a)~~ **Residential Design Guidelines.** The construction of new residential buildings and
18 alterations of existing residential buildings in the Westwood Park Residential Character
19 District shall be consistent with the design policies and guidelines of the ~~General Master~~ Plan
20 and with the previously adopted "Residential Design Guidelines" as amended by portions of
21 "The Westwood Park Association Residential Design Guidelines," adopted by ~~City~~ Planning
22 Commission Resolution Number 13992. The Zoning Administrator may require modifications
23 to the exterior of a proposed new residential building or proposed alteration of an existing
24 residential building in order to bring it into conformity with the ~~General Master~~ Plan and with the
25 "Residential Design Guidelines" as amended. These modifications may include, but are not

1 limited to, changes in siting, building envelope, scale, texture and detailing, openings, and
2 landscaping.

3 **SEC. 249.52. TREASURE ISLAND/YERBA BUENA ISLAND SPECIAL USE DISTRICT.**

4 (a) **Purpose and Boundaries.** In order to give effect to the Treasure Island/Yerba
5 Buena Island Project as approved by the Board of Supervisors (File Nos. 110226 and
6 110291), there shall be a Treasure Island/Yerba Buena Island Special Use District as
7 designated on Sectional Map SU14 of the Zoning Maps of the City and County of San
8 Francisco. The boundaries of the Treasure Island/Yerba Buena Island Special Use District
9 include all areas of Treasure Island and Yerba Buena Island as shown on Zoning Sectional
10 Map ZN14. Any property within the Special Use District owned by the United States
11 Department of Labor, United States Coast Guard, Federal Highway Administration or
12 California Department of Transportation is hereby declared to be in a P (Public Use) District
13 unless reclassified in accordance with the provisions of this Code. The purpose of this Special
14 Use District is to facilitate the City's long-term goal of implementing the creation of a new City
15 neighborhood on Treasure Island and Yerba Buena Island, which will provide benefits to the
16 City such as significant amounts of new affordable housing, increased public access and open
17 space, transportation improvements, extensive infrastructure improvements, and recreational
18 and entertainment opportunities, while creating jobs and a vibrant, sustainable community.
19 This Special Use District shall supersede, in its entirety, all other provisions of this Planning
20 Code that would otherwise be applicable to Treasure Island and Yerba Buena Island except
21 with respect to (1) Planning Code sections adopted by ballot proposition prior the effective
22 date of the Ordinance adopting this Special Use District, which consist of the sections of the
23 Planning Code adopted or amended by Proposition M (1986) (Section ~~s~~-101.1 [General Master
24 Plan Consistency and Implementation], Section 164, and Sections 320-325); Proposition K
25 (1984) (Shadow Ban) (Section 295); Proposition G (2002) (General Advertising Signs

1 Prohibited) (Sections 602.7 and 611); and Proposition G (2006) (Limitation on Formula Retail
2 in NC Districts) (Section 703.4); (2) any Planning Code sections adopted or amended in
3 connection with this Special Use District, including Sections ~~102.5 (District)~~; 105 (Zoning Map);
4 201 (Use Districts); 263.26 (Treasure Island/Yerba Buena Island Height and Bulk District) and
5 249.52 (Treasure Island/Yerba Buena Island Special Use District), and (3) any other section
6 of the Planning Code referenced herein (but only to the extent and for the purposes stated
7 herein).

9 (g) **Review and Approval of Vertical Development.**

11 (4) **Schematic Design Document Applications under Planning Commission**
12 **Jurisdiction.**

13 * * * *

14 (E) **Public Hearing for Large Projects.** Prior to decision by the *Director*
15 *of Planning Director* pursuant to ~~s~~Subsection (g)(4)(C) above, each project subject to the below
16 criteria shall be presented at a regularly scheduled hearing of the Planning Commission. Such
17 hearing shall be calendared within 30 days after the application is complete or deemed
18 complete. If a public hearing is required under subsection (g)(4)(D) and this ~~s~~Subsection, the
19 Planning Commission shall ~~hear~~ jointly calendar *and hear* both items, to take action on the
20 Major Modification and to provide comment only on the project design. The *Director of*
21 *Planning Director* shall consider all comments from the public and the Planning Commission in
22 making his or her decision to approve, conditionally approve, or disapprove the project design.
23 Criteria necessitating public hearing are as follows:

25 **SEC. 249.60. MISSION ALCOHOLIC BEVERAGE SPECIAL USE DISTRICT.**

2 (a) **Prohibition of New Liquor Stores.** No new Liquor Store, as defined in Section 102
3 and 790.55 of this Code, shall be permitted in the SUD, except that an existing Liquor Store
4 may relocate pursuant to subsection (c) ~~(d)~~ below.

6 **SEC. 249.65. BAYSHORE BOULEVARD HOME IMPROVEMENT SPECIAL USE DISTRICT.**

8 (c) **Controls.** The following controls shall apply in the Bayshore Boulevard Home
9 Improvement Special Use District:

10 (1) A Retail Sales and *Personal* Services use as defined in Section 102 of this
11 Code, *except for Motels and Hotels*, shall be permitted regardless of the use size limitations in
12 the PDR Zoning Control Table, however the use size controls set forth in Section 121.6 and

23 stated therein. Among these purposes are the following:

16 be placed in a publicly conspicuous location for pedestrian viewing. The plaque shall state the
17 right of the public to pass through the alley and stating the name and address of the owner or
18 owner's agent responsible for maintenance. The ~~plaque~~ plaque shall be of no less than 24
19 inches by 36 inches in size.

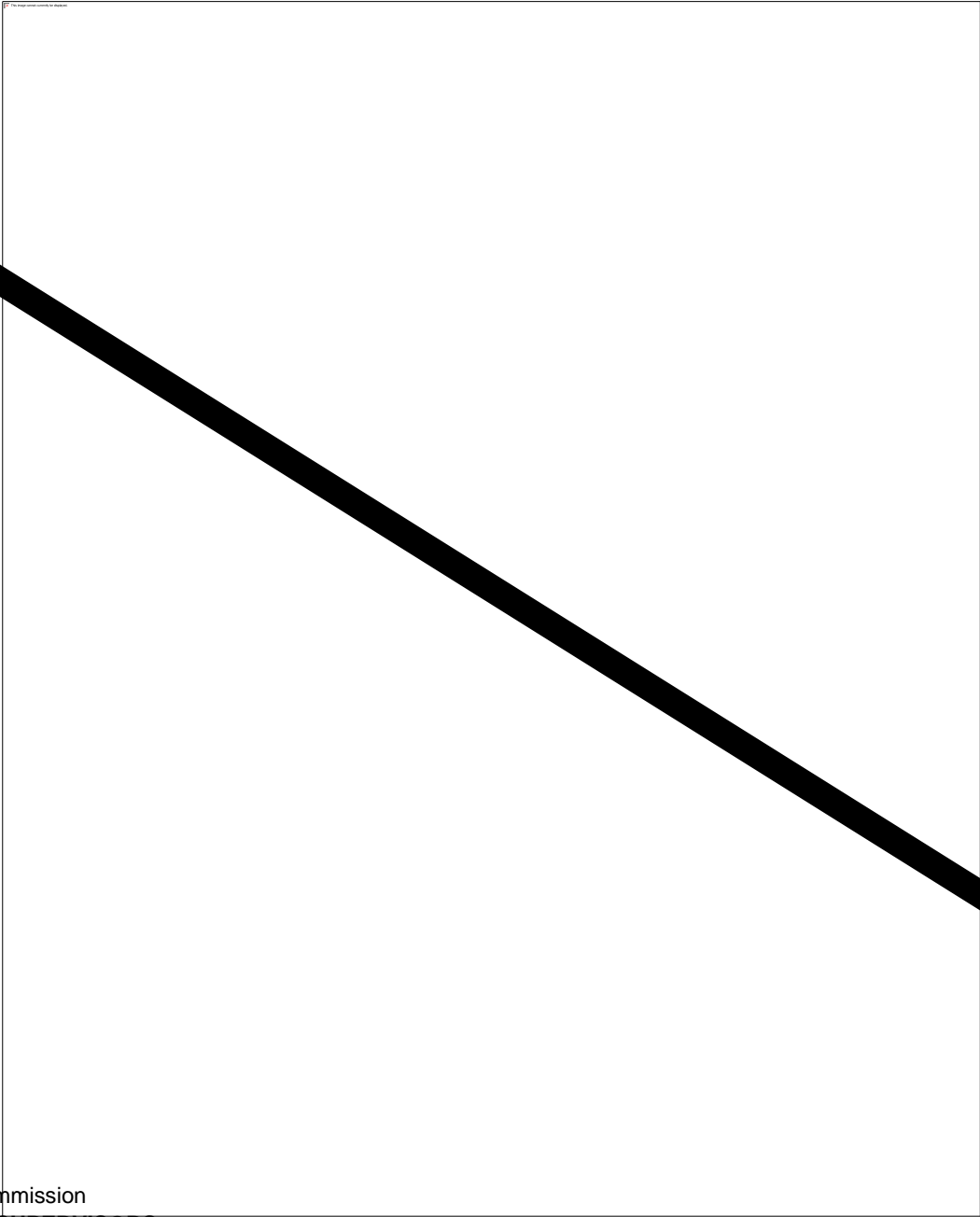
21 **SEC. 271. BULK LIMITS: SPECIAL EXCEPTIONS, IN DISTRICTS OTHER THAN C-3.**

22 **(a) General.** The bulk limits prescribed by Section 270 have been carefully considered
23 in relation to objectives and policies for conservation and change in districts other than C-3.
24 There may be some exceptional cases in which these limits may properly be permitted to be
25 exceeded to a certain degree; however, following public review and exploration of

1 alternatives, provided there are adequate compensating factors. Such deviation might occur,
2 when the criteria of this Section are met, for one or both of the following positive reasons:

3 (1) Achievement of a distinctly better design, in both a public and a private
4 sense, than would be possible with strict adherence to the bulk limits, avoiding an
5 unnecessary prescription of building form while carrying out the intent of the bulk limits and

5 **SEC. 290. HEIGHT AND BULK LIMITS FOR OPEN SPACE DISTRICTS.**

6 In the Open Space Districts designated by the symbol "OS" on Sectional Maps Nos.
7 ~~HT01~~ ~~4H~~ through ~~HT13~~ ~~43H~~ of the Zoning Map, the height and bulk of buildings and structures
8 shall be determined in accordance with the objectives, principles and policies of the General
9 ~~Master~~ Plan, and no building or structure or addition thereto shall be permitted unless in
10 conformity with the General Master Plan. The inclusion of land in Open Space Districts is
11 intended to indicate its principal or exclusive purpose as open space, with future development

4 (b) The ~~City~~ Planning Commission shall conduct a hearing and shall disapprove the
5 issuance of any building permit governed by the provisions of this Section if it finds that the
6 proposed project will have any adverse impact on the use of the property under the
7 jurisdiction of, or designated for acquisition by, the Recreation and Park Commission because
8 of the shading or shadowing that it will cause, unless it is determined that the impact would be
9 insignificant. The ~~City~~ Planning Commission shall not make the determination required by the
10 provisions of this Subsection until the general manager of the Recreation and Park
11 Department in consultation with the Recreation and Park Commission has had an opportunity
12 to review and comment to the ~~City~~ Planning Commission upon the proposed project.

13 (c) The ~~City~~ Planning Commission and the Recreation and Park Commission, after a
14 joint meeting, shall adopt criteria for the implementation of the provisions of this Section.

15 (d) The Zoning Administrator shall determine which applications for building permits
16 propose structures which will cast a shade or shadow upon property under the jurisdiction of,
17 or designated for acquisition by, the Recreation and Park Commission. As used in this
18 Section, "property designated for acquisition by the Recreation and Park Commission" shall
19 mean property which a majority of each of the Recreation and Park Commission and the ~~City~~
20 Planning Commission, meeting jointly, with the concurrence of the Board of Supervisors, have
21 recommended for acquisition from the Open Space Acquisition and Park Renovation Fund,
22 which property is to be placed under the jurisdiction of the Recreation and Park Commission.

23 **SEC. 301. GENERAL DESCRIPTION OF ZONING PROCEDURES.**

24 This Section is a summary of provisions more fully described in the remainder of this
25 Article.

1 The final legislative authority for enactment and amendment of the zoning provisions
2 contained in this Code resides in the Board of Supervisors. However, all proposals for
3 reclassifications of property or other amendments are considered first by the ~~City~~ Planning
4 Commission, and its disapprovals are final unless overruled by the Board of Supervisors.

5 The provisions of this Code are administered by the Zoning Administrator and other
6 staff members of the Planning Department ~~of City Planning~~, by means of public information,
7 review of permit applications, keeping of records, interpretation of the meaning and intent of
8 the Code, and enforcement actions against violations. The Zoning Administrator is also
9 responsible for reviewing the effectiveness of the Code and recommending appropriate
10 changes to the legislative authorities.

11 Certain specified uses and features in various zoning districts require approval by the
12 ~~City~~ Planning Commission through conditional use procedures, in which the Commission
13 determines whether the provisions of the Code are met.

14 The decisions of the Commission in these cases may be appealed to the Board of
15 Supervisors.

16 In some cases, provisions of the Code may be relaxed by means of variances or
17 administrative review granted by the Zoning Administrator; provided, for a variance, that
18 certain specified findings can be made, and for administrative review, that the conditions of
19 the section authorizing such review are satisfied. Decisions in these cases may be appealed
20 to the Board of ~~Permit~~ Appeals.

21 The responsibilities of each of these persons and agencies are derived from the San
22 Francisco Charter.

23 **SEC. 303. CONDITIONAL USES.**

24 * * * *

25 (n) **Massage Establishments.**

1 (1) With respect to Massage Establishments that are subject to Conditional Use
2 authorization, as defined in Sections 102, 790.60, and 890.60 of this Code, in addition to the
3 criteria set forth in Subsection (c) above, the Commission shall make the following findings:

4 (A) Whether the applicant has obtained, and maintains in good standing,
5 a permit for a Massage Establishment from the Department of Public Health pursuant to
6 Section 29.2510 of the San Francisco Health Code;

8 (p) **Adult Business, General Entertainment and Other Entertainment Uses.**

9 (1) With respect to ~~e~~Conditional ~~#~~Use authorization applications for Adult
10 Business, General Entertainment and Other Entertainment uses, such use or feature shall:

11 (A) If the use is an Adult Business, it shall not be located within 1,000 feet
12 of another such use; and/or

13 (B) Not be open between two a.m. and six a.m; and

14 (C) Not use electronic amplification between midnight and six a.m.; and

15 (D) Be adequately soundproofed or insulated for noise and operated so
16 that incidental noise shall not be audible beyond the premises or in other sections of the
17 building and fixed-source equipment noise shall not exceed the decibel levels specified in the
18 San Francisco Noise Control Ordinance.

19 (2) Notwithstanding the above, the Planning Commission may authorize a
20 conditional use which does not satisfy the criteria set forth in ~~(q)~~(1)(B) and/or ~~(q)~~(1)(C)2
21 above, if facts presented are such to establish that the use will be operated in such a way as
22 to minimize disruption to residences in and around the district with respect to noise and crowd
23 control.

24 (3) The action of the Planning Commission approving a conditional use does not
25 take effect until the appeal period is over or while the approval is under appeal.

2 **(r) Development of Large Lots in RTO and RTO-M Districts.**

3 In order to promote, protect, and maintain a scale of development that is appropriate to each
4 district and compatible with adjacent buildings, new construction or significant enlargement of existing
5 buildings on lots of the same size or larger than the square footage stated in Table 209.4 under Large
6 Project Review shall be permitted only as conditional uses subject to the provisions set forth in this
7 Section of this Code.

8 In addition to the criteria of Section 303(c)(1) of this Code, the Planning Commission shall
9 consider the extent to which the following criteria are met:

10 (1) The mass and articulation of the proposed structures are compatible with the
11 intended scale of the district.

12 (2) For development sites greater than 1/2-acre, the extension of adjacent alleys or streets
13 onto or through the site, and/or the creation of new publicly-accessible streets or alleys through the
14 site as appropriate, in order to break down the scale of the site, continue the surrounding existing
15 pattern of streets and alleys, and foster beneficial pedestrian and vehicular circulation.

16 (3) The site plan, including the introduction of new streets and alleys, the provision of
17 open space and landscaping, and the articulation and massing of buildings, is compatible with the
18 goals and policies of the applicable Area Plan in the General Plan.

19 **SEC. 304. PLANNED UNIT DEVELOPMENTS.**

21 (d) **Criteria and Limitations.** The proposed development must meet the criteria
22 applicable to conditional uses as stated in Section 303(c) and elsewhere in this Code. In
23 addition, it shall:

1 (5) In R Districts, include ~~e~~Commercial ~~u~~Uses only to the extent that such uses
2 are necessary to serve residents of the immediate vicinity, subject to the limitations for NC-1

4 the provisions of Section ~~230~~ 231 of this Code;

6 **SEC. 304.5. INSTITUTIONAL MASTER PLANS.**

7 * * * *

8 (b) **When Required.** Each Hospital and each Post-Secondary Educational Institution in
9 the City and County of San Francisco (for the purposes of this Section collectively referred to
10 as "institution(s)"), including Group Housing affiliated with and operated by any such institution
11 shall have on file with the Planning Department a current ~~i~~Institutional ~~m~~Master ~~p~~Plan
12 describing the existing and anticipated future development of that institution as provided in
13 Subsection (c) below. ~~Medical and educational i~~Institutions of less than 50,000 square feet or
14 ~~medical and educational institutions~~ of less than 100,000 square feet in the C-3 district may
15 submit an Abbreviated Institutional Master Plan as described in Subsection (d) below.

16 Thereafter, at intervals of two years, each such institution shall file an Update with the
17 Planning Department describing the current status of its ~~i~~Institutional ~~m~~Master ~~p~~Plan. The
18 requirements for an ~~u~~Update are provided in Subsection (f) below.

19 The Zoning Administrator shall be notified whenever the following occur to determine
20 whether a new Institutional Master Plan or an Update shall be required: there are significant
21 revisions to the information contained in the Institutional Master Plan; or 10 years have
22 passed since the last Institutional Master Plan was submitted and heard by the Planning
23 Commission (as described by Subsection (e) below). Significant revisions may include plans
24 to construct new facilities that were not previously discussed in the Institutional Master Plan,
25 plans to demolish existing facilities that were not discussed in the Institutional Master Plan,

1 closure of an existing unit, opening of a new unit, change in use of an existing unit or inpatient
2 facility, an increase in the ~~institutions~~ institution's size by 10,000 square feet or 25% of total
3 square footage (whichever is less), or significant changes in use of existing facilities that were
4 not discussed in the Institutional Master Plan.

5 (c) **Format and Substance of the Institutional Master Plan.** In the case of an
6 institution occupying a site area of 50,000 or more square feet (100,000 or more square feet
7 in the C-3 District), or occupying a site area of less than 50,000 square feet (100,000 or more
8 square feet in the C-3 District) but anticipating future expansion over 50,000 square feet
9 (100,000 or more square feet in the C-3 District), the plan submitted shall be a full Institutional
10 Master Plan and shall at a minimum contain textual and graphic descriptions of:

11 * * * *

12 (3) The development plans of the institution for a future period of not less than
13 10 years, and the physical changes in the institution projected to be needed to achieve those
14 plans. Any plans for physical development during the first five years shall include the site
15 area, ground coverage, building bulk, approximate floor area by function, off-street parking,
16 circulation patterns, areas for land acquisition, and timing for the proposed construction. In
17 addition, with respect to plans of any duration, the submission shall contain a description and
18 analysis of each of the following:

19 (A) The conformity of proposed development plans to the General
20 Comprehensive Plan (~~Master Plan~~) of the City and County of San Francisco, and to any
21 neighborhood plans on file with the Planning Department,

1 **SEC. 306.7. INTERIM ZONING CONTROLS.**

2 Interim zoning controls may be imposed by resolution of the ~~City~~ Planning Commission
3 or the Board of Supervisors through the exercise of a legislative rule-making power subject to
4 the procedures and standards and for the purposes set forth in this Section.

5 (a) **Purposes.** This interim zoning controls process is found and declared to be
6 necessary to fulfill the purposes of this Code as stated in Section 101 herein. The Board of
7 Supervisors and the ~~City~~ Planning Commission are hereby authorized to impose interim
8 zoning controls to suspend temporarily the processing of certain applications for demolition
9 permits, building permits and other land use authorizations which may be in conflict with a
10 contemplated zoning proposal which the Board of Supervisors, the ~~City~~ Planning Commission
11 or the Planning Department ~~of City Planning~~ is considering or studying or intends to study
12 within a reasonable time. The provisions of this Section will allow time for the orderly
13 completion of a planning study and for the adoption of appropriate legislation. Interim zoning
14 controls are necessary to ensure that the legislative scheme which may be ultimately adopted
15 is not undermined during the planning and legislative process by the approval or issuance of
16 permits authorizing the alteration, construction or demolition of buildings or the establishment
17 or change of uses which will conflict with that scheme. In determining whether to impose
18 interim zoning controls, the body imposing the controls shall consider the impact on the public
19 health, safety, peace and general welfare if the proposed controls are not imposed, including,
20 but not limited to, the public interest in the following objectives:

21 * * * *

22 (b) **Effect of Interim Zoning Controls Upon Permit Applications.** A resolution of the
23 Board of Supervisors or of the ~~City~~ Planning Commission imposing interim zoning controls
24 shall set forth the duration of the interim zoning controls. Once interim zoning controls are
25 imposed pursuant to this Section, and for the duration of the controls and any extension

1 permitted by this Section, no department of the City and County of San Francisco, including
2 the Board of *Permit* Appeals, may approve any application for a demolition permit, a building
3 or site permit or for any other permit or license authorizing the demolition, alteration or
4 construction of any building or the establishment of any use unless the action proposed would
5 conform both to the existing provisions of the *City* Planning Code and also to the provisions of
6 the resolution imposing the controls. Failure of the Board of Supervisors or the *City* Planning
7 Commission to act on a proposed interim control within 120 days of its initiation shall be
8 deemed to constitute disapproval. At any time after the first noticed hearing, in order to insure
9 that the purpose for imposing interim controls is not undermined during the period when their
10 adoption is being considered, the body considering the proposed controls may by resolution
11 issue an order directing the Zoning Administrator, the Director Superintendent of the Department
12 Bureau of Building Inspection, the Board of *Permit* Appeals, and other permit-issuing and
13 permit-approving agencies to suspend action on applications which propose a use prohibited
14 by the proposed interim controls pending final action on the controls; provided, however, that
15 such order shall not apply to applications filed more than 60 days before the first noticed
16 hearing and shall not prohibit action on applications which would otherwise be deemed
17 approved during the period of such suspension pursuant to Government Code Sections
18 65950 - 65957.1.

19 * * * *

20 (d) **Environmental Review.** The provisions of this Section shall govern the
21 environmental review process conducted by the Director of Planning upon initiation of the
22 interim zoning controls process by the Board of Supervisors.

23 * * * *

24 (3) If a preliminary negative declaration is published and an appeal is filed within
25 10 days, the Planning Commission shall, within 40 days of the date that the appeal of the

1 preliminary negative declaration is filed, either affirm the preliminary negative declaration or
2 overrule the preliminary negative declaration and order the preparation of an environmental
3 impact report. The Director of Planning shall transmit to the Clerk of the Board of Supervisors
4 the resolution of the ~~City~~ Planning Commission affirming or overruling the preliminary negative
5 declaration within two business days following its adoption.

6 (4) If the Planning Department ~~of City Planning~~ or on appeal the ~~City~~ Planning
7 Commission determines that an environmental impact report must be prepared before the
8 imposition of the proposed interim controls, no work need be commenced for preparation of
9 that document unless the Board of Supervisors adopts a motion by majority vote, authorizing
10 the preparation of that document. The Clerk of the Board of Supervisors shall transmit a copy
11 of that motion to the Director of Planning, who shall prepare or cause to be prepared the
12 environmental impact report. A final environmental impact report shall be prepared within 18
13 months after the transmittal of the motion authorizing preparation of that document by the
14 Board to the Director of Planning. The Director shall complete the environmental impact report
15 notwithstanding the fact that the proposed controls have been deemed disapproved after the
16 expiration of 120 days as set forth in Subsection (b), unless directed otherwise by the Board.
17 Upon completion of that document, the same interim controls may be initiated and thereafter
18 adopted within 120 days of their initiation. If the Board votes on a motion authorizing the
19 preparation of an environmental impact report and the motion fails, the interim zoning controls
20 process shall terminate on that date. If the Board does not vote on a motion authorizing the
21 preparation of an environmental impact report within 30 days of the date of receipt of
22 notification that an environmental impact report is required and of the proposed Board motion
23 which would authorize its preparation, the interim zoning controls process shall terminate on
24 the 30th day after receipt of such notification.

25 * * * *

1 **(e) Interim Zoning Controls Imposed by the ~~City~~ Planning Commission.** The
2 procedure set forth in this Section shall govern the imposition of interim zoning controls by the
3 ~~City~~ Planning Commission. The procedure may be initiated upon application pursuant to
4 Section 306 of the Code by an interested property owner, resident, or commercial lessee as
5 defined by Section 302(b) herein or by adoption of a resolution proposing imposition of the
6 interim zoning controls by the ~~City~~ Planning Commission. A resolution proposing imposition of
7 the interim zoning controls shall either contain the text of the proposed controls or refer to and
8 incorporate by reference an exhibit which does so. The resolution and any exhibit text shall be
9 approved as to form by the City Attorney. Upon adoption of that resolution or receipt of the
10 application, the Zoning Administrator shall provide the notice required by Subsection (g) within
11 20 days. Within 30 days after the required notice has been provided, the Commission shall
12 hold a hearing on the proposed interim controls. Upon completion of environmental review as
13 required by applicable provisions of CEQA and the ~~San Francisco~~ Administrative Code, the
14 Commission may adopt a resolution imposing the interim zoning controls by a majority vote.
15 Matters relating to environmental review which require a hearing may be considered at the
16 same Commission meeting at which the Commission considers and acts upon the proposed
17 controls, so long as environmental review is completed first. Any hearing to consider the
18 imposition of interim zoning controls may be continued for further consideration to another
19 date pursuant to the regular notice requirements applicable to the Commission.

20 **(f) Ratification or Disapproval of Commission Action.** Each proposed interim
21 control voted on by the ~~City~~ Planning Commission and failing of passage and each interim
22 control imposed by the ~~City~~ Planning Commission shall be forwarded within two business
23 days of the Commission action to the Board of Supervisors, which may ratify or disapprove
24 the action taken by the ~~City~~ Planning Commission. The interim controls imposed by the ~~City~~
25 Planning Commission shall remain in effect and be deemed ratified unless and until the Board

1 of Supervisors disapproves the controls within 90 days of the date that they are received by
2 the Clerk of the Board. If disapproved, the interim zoning controls shall be of no further force
3 and effect. The Board of Supervisors may disapprove the action of the ~~City~~ Planning
4 Commission ~~only~~ by a majority vote ~~of not less than of all the members of the Board, except that in~~
5 ~~the event that one or more of the full membership of the Board is disqualified or excused from voting~~
6 ~~because of an interest prohibited by general law or the San Francisco Charter, any such disapproval~~
7 ~~shall be by a vote of not less than of all members of the Board that are not disqualified or excused;~~
8 ~~provided, however, that in the event that a quorum of all members of the Board is disqualified or~~
9 ~~excused from voting because of an interest prohibited by general law or the Charter, the action of the~~
10 ~~City Planning Commission shall be deemed approved.~~ In the event the Board disapproves the
11 action of the Commission when the Commission has disapproved a proposed interim control,
12 the Board shall, not later than its next regularly scheduled meeting, adopt the proposed
13 interim control. In considering whether to ratify or disapprove Commission action, the Board
14 shall consider the purposes and objectives set forth in Subsection (a).

15 (g) **Notice.** Notice of the time and place of a public hearing on interim zoning controls
16 before the Planning Commission if the Planning Commission initiates the controls, or before
17 the Board of Supervisors or a committee of the Board if a member of the Board initiates the
18 controls, shall be as follows:

19 * * * *

20 (2) By posting at the office of the Board of Supervisors and the Planning
21 Department ~~of City Planning~~ nine days prior to the date of hearing; and

22 * * * *

23 Notice of a public hearing by the Board of Supervisors or a committee of the Board for
24 the ratification or disapproval of interim controls imposed by the ~~City~~ Planning Commission
25 shall be given pursuant to Subsections (1), (2), (3) and (5) of this Subsection.

1 * * * *

2 (i) **Planning Study.** Upon the imposition of interim zoning controls by either the Board
3 of Supervisors or the ~~City~~ Planning Commission, the Planning Department ~~of City Planning~~
4 shall conduct a study of the contemplated zoning proposal and shall propose permanent
5 legislation. As to any controls which are placed in effect for more than six months, the staff of
6 the ~~City~~ Planning Department shall report to the entity imposing the controls six months from
7 the date of the imposition of the controls and at least every six months thereafter. The report
8 shall inform that body of (1) the status of the planning study, (2) the findings and
9 recommendations to date, and (3) the estimated time of completion of such study and
10 proposed permanent legislation. These reports shall be considered in a public hearing duly
11 noticed in accordance with the basic rules of the body that imposed the interim zoning
12 controls.

13 **SEC. 306.8. POSTING OF SIGNS REQUIRED.**

14 (a) **Hearings for Which Notice Required.** In addition to the requirements for notice
15 provided elsewhere in this Code, the requirements for notice set forth in this Section shall
16 apply to hearings before the ~~City~~ Planning Commission or the Zoning Administrator (1) on an
17 application for a conditional use or variance, (2) for every amendment to reclassify property
18 initiated by application as permitted in Section 302(b) where the area sought to be reclassified
19 is ½ acre or less (exclusive of streets, alleys and other public property) and where the
20 applicant owns all or a portion of the property to be reclassified or is a resident or commercial
21 lessee thereof, (3) for any permit application or project authorization application reviewed
22 pursuant to Sections 309 or 322, and (4) for any application for a building or site permit
23 authorizing a new building the consideration or approval of which is scheduled before the ~~City~~
24 Planning Commission. This ~~s~~Section shall not apply to variance applications involving a less
25

1 than 10 percent deviation as described in Section 305(c) or to hearings or actions relating to
2 environmental review.

3 * * * *

4 (c) **Contents and Size of Signs.** The sign shall be at least 30 inches by 30 inches,
5 unless the application relates to a vacant site or vacant building, in which case the Zoning
6 Administrator may require a sign up to eight feet wide and four feet high upon a determination
7 that the larger sign will provide better public notice. The sign shall be entitled NOTICE OF
8 ZONING HEARING. The lettering shall be at least 1¼-inch capital letters for the title. All other
9 letters shall be at least ¾-inch uppercase and ½-inch lower-case. The sign shall provide
10 notice of the case number, the time, date, location and purpose of the public hearing, a
11 description of the proposed project, and the procedure for obtaining additional information.

12 Every person subject to the requirements of this Section shall obtain from the *Planning*
13 Department ~~of City Planning~~ the sign on submission of application which is to be posted, and
14 shall provide such additional information on the sign as required by this Section and any
15 written directions provided by the Zoning Administrator; provided, however, that where the
16 Zoning Administrator requires a sign larger than 30 by 30 inches, the applicant shall provide
17 the sign. The Department shall charge a fee to applicants in an amount determined
18 appropriate to cover the cost of providing the sign.

19 * * * *

20 (e) **Declaration Required; Failure to Comply.** The applicant, other than an applicant
21 for a reclassification, shall submit at the time of the hearing a declaration signed under penalty
22 of perjury stating that the applicant has complied with the provisions of this Section. If any
23 person challenges the applicant's compliance with this Section, the Commission or, as to
24 variance hearings the Zoning Administrator, shall determine whether the applicant has
25 substantially complied and, if not, shall continue the hearing for that purpose. A challenge may

1 be raised regarding compliance with the provisions of this Section by any person after the
2 hearing by filing a written statement with the Zoning Administrator, or such challenge may be
3 raised by the Zoning Administrator, but no challenge may be filed or raised later than 30 days
4 following Commission action, or as to variance hearings 10 days following the decision. If no
5 challenge is filed within the time required, it shall be deemed conclusive that the applicant
6 complied with the provisions of this Section. If it is determined, after a hearing for which at
7 least five days' notice has been given to the person filing the challenge and the applicant, that
8 the applicant has not substantially complied with the provisions of this Section, the action of
9 the ~~City~~ Planning Commission or the Zoning Administrator shall be deemed invalid and the
10 matter shall be rescheduled for hearing after the required notice has been given.

11 Notwithstanding any other provision of this Section, an application may be denied if
12 continuance or delay of action on the application would result in an application being deemed
13 approved pursuant to Government Code Sections 65920 et seq.

22 Restaurant, as defined in Section s 102 and 790.90, a Restaurant, as defined in Section s 102
23 and 790.91, a ~~m~~Massage ~~e~~Establishment, as defined in Section s 102 and 790.60, an ~~o~~Outdoor
24 ~~a~~Activity ~~A~~rea, as defined in Section 790.70, an ~~a~~Adult or ~~o~~Other ~~e~~Entertainment use, as
25 defined in Sections 790.36 and 790.38, a ~~f~~Fringe ~~f~~Financial ~~s~~Service use, as defined in

1 Section 102 and 790.111, Tobacco Paraphernalia Establishments as defined in Sections 102 and
2 790.123, or Group Housing as defined in Sections 102 and 790.88(b) shall be subject to the
3 provisions of Subsection 312(d); provided, however, that a change of use from a Restaurant
4 to a Limited-Restaurant shall not be subject to the provisions of Subsection 312(d). In all RED
5 and Eastern Neighborhoods Mixed Use Districts all building permit applications for a change
6 of use from any one anyone land use category to another land use category shall be subject to
7 the provisions of Subsection 312(d). In addition, any accessory massage use in the Ocean
8 Avenue Neighborhood Commercial Transit District shall be subject to the provisions of
9 Subsection 312(d).

10 For the purposes of this Subsection, "land use category" shall mean those categories
11 used to organize the individual land uses which appear in the use tables in Article 8,
12 immediately preceding a group of individual land uses, and include the following: ~~R~~Residential
13 ~~U~~se, ~~I~~Institutional ~~U~~se, ~~R~~Retail ~~S~~Sales and ~~S~~Service ~~U~~se, assembly, ~~R~~Recreation and

2 Mixed Use Districts; Section 840 through 843 for the Eastern Neighborhoods Mixed Use

4 determinations on such applications are set forth in Section 303(c) of this Code. Additional
5 criteria for determinations on applications pursuant to zoning categories .10, .11, and .21 of

7 determinations on certain applications within Mixed Use Districts are set forth in Sections
8 263.11 and 803.5 through 803.9 of this Code. Additional criteria for determination on certain

6 Department ~~of City Planning~~ pursuant to Sections 321 and 322 of this Code.

7 (j) "Retail ~~u~~se" shall mean supply of commodities on the premises including, but not
8 limited to, stores, shops, ~~r~~estaurants, ~~b~~ars, eating and drinking businesses, and Retail Sales
9 and Services ~~the~~ uses defined in Planning Code Sections 102, except for Hotels and Motels 218
10 and 220 through 225.

12 **SEC. 321. OFFICE DEVELOPMENT: ANNUAL LIMIT.**

13 (a) **Limit.**

15 (2) The following amounts of additional office space shall count against the
16 maximum set in Subsection (a)(1):

17 * * * *

18 (D) All additional office space in structures exempt under Section
19 320(g)(4) or 320(g)(6) or the last sentence of Section 175.1(b), or which satisfy the
20 substantive terms of either of said exemptions but for which the first building or site permit is
21 authorized or conditional use or variance approved by the ~~City~~ Planning Commission after
22 June 15, 1985 but before the effective date of this ordinance.

23 The additional office space described in Subsection (a)(2)(A) shall be taken into
24 account with respect to all proposed office developments which are considered after the first
25 site or building permit is approved for issuance for the described project. The additional office

1 space described in Subsections (a)(2)(B) and (a)(2)(D) shall be taken into account with
2 respect to all proposed office developments which are considered during the approval period
3 and after the project or the added additional office space is first authorized or a conditional
4 use or variance approved by the ~~City~~ Planning Commission. The additional office space
5 described in Subsection (a)(2)(C) shall be taken into account with respect to all proposed
6 office developments which are considered during the approval period and after
7 commencement of construction of the described structures. Modification, appeal or
8 disapproval of a project described in this Section shall affect the amount of office space
9 counted under this Section in the time and manner set forth for office developments in Section
10 321(c).

11 (3) The Planning Department ~~of City Planning~~ shall maintain and shall make
12 available for reasonable public inspection a list showing:

13 * * * *

14 (4) Not less than six months before the last date of the approval period, the
15 Planning Department ~~of City Planning~~ shall submit to the Board of Supervisors a written report,
16 which report shall contain the ~~City~~ Planning Commission's recommendation with respect to
17 whether, based on the effects of the limitation imposed by this Section on economic growth
18 and job opportunities in the City, the availability of housing and transportation services to
19 support additional office development in the City, office vacancy and rental rates, and such
20 other factors as the Commission shall deem relevant, there should continue to be a
21 quantitative limit on additional office space after the approval period, and as to what amount of
22 additional office space should be permitted under any such limit.

23 (5) Every holder of a site permit issued on or after July 1, 1982 for any office
24 development, as defined in Section 320(g) without regard to Subsections (g)(2) through (g)(5),

1 shall provide to the ~~City~~ Planning Commission reports containing data and information with
2 respect to the following:

3 (A) Number of persons hired for employment either in construction of the
4 development or, to the extent such information is available to the permittee, by users of the
5 completed building;

6 (B) The age, sex, race and residence, by City, of each such person;

7 (C) Compensation of such persons, classified in \$5,000 increments,
8 commencing with annualized compensation of \$10,000;

9 (D) The means by which each such person most frequently travels to and
10 from the place of employment.

11 Such reports shall commence on October 1, 1985 and continue quarterly thereafter
12 during the approved period. A report containing information by quarter for the period between
13 July 1, 1982 and the effective date of the ordinance shall be submitted not later than
14 December 31, 1985. The ~~City~~ Planning Commission shall have full access to all books,
15 records and documents utilized by any project sponsor in preparation of the written reports
16 referred to above, and shall inspect such books, records and documents from time to time for
17 purposes of authenticating information contained in such reports.

18 (b) **Guidelines.**

19 (1) During the approval period, the ~~City~~ Planning Commission, and the Board of
20 Supervisors and Board of ~~Permit~~ Appeals on appeal from the ~~City~~ Planning Commission shall

22 office developments which they shall determine in particular promote the public welfare,
23 convenience and necessity, and shall be empowered under this Section to disapprove the

25 approved, in accord with Sections 320 through 323 of this Code, a project authorization.

1 (2) The following proposed office developments, subject to all other applicable
2 sections of this Code and other applicable law, shall be approved under this Section in
3 preference to all others:

4 (A) All proposed developments to the extent approval is required by court
5 order; and, thereafter,

6 (B) Subject to Subsection (a)(1) of this Section, all proposed office
7 developments which were approved by the ~~City~~ Planning Commission during the approval
8 period, but subsequently disapproved by any administrative appellate body or court, if and
9 when said disapproval is later reversed.

10 (3) In determining which office developments best promote the public welfare,
11 convenience and necessity, the Board of Supervisors, Board of ~~Permit~~ Appeals and ~~City~~
12 Planning Commission shall consider:

13 (A) Apportionment of office space over the course of the approval period
14 in order to maintain a balance between economic growth, on the one hand, and housing,
15 transportation and public services, on the other;

16 (B) The contribution of the office development to, and its effects on, the
17 objectives and policies of the General Master Plan;

18 * * * *

19 (5) With respect to any office development which shall come before the Board of
20 Supervisors for conditional use review, that Board shall consider, in addition to those criteria
21 made applicable by other provisions of law, the criteria specified in Subsection (b)(3). As to
22 any such office development, the decision of the Board of Supervisors with respect to the
23 criteria specified in Subsection (b)(3) shall be a final administrative determination and shall not
24 be reconsidered by the ~~City~~ Planning Commission or Board of ~~Permit~~ Appeals.
25

1 (6) The ~~City~~ Planning Commission shall establish procedures for coordinating
2 review of project authorization applications under Section 322 with review under Section 309
3 of this Code. The Commission may hold hearings under Sections 309 and 322 in such
4 sequence as it may deem appropriate, but may not issue any project authorization until the
5 requirements of Section 309 have been satisfied.

6 (c) **Appeal and Modification.**

8 (2) The amount of additional office space of any development shall not count
9 against the maximum for the approval period, beginning from the time the office development
10 loses its approved status on the Planning Department ~~of City Planning~~ list under Subsection
11 (c)(1); provided, however, that if a decision disapproving an office development permits
12 construction of a part of the project, the permitted additional office space only shall continue to
13 count against the maximum, unless and until all building or site permits for the development
14 expire or are cancelled, revoked or withdrawn.

16 (d) **Unbuilt Projects; Progress Requirement.**

18 (2) Construction of an office development shall commence within 18 months of
19 the date the project is first approved, or, in the case of development in the C-3-O(SD) District
20 the development shall commence within three (3) years. Notwithstanding the above provision,
21 office projects larger than 500,000 gross square feet in the C-3-O(SD) District shall
22 commence construction within five (5) years. Failure to begin work within that period, or
23 thereafter to carry the development diligently to completion, shall be grounds to revoke
24 approval of the office development. Neither the Department of Building Inspection ~~Public Works~~

1 nor the Board of *Permit* Appeals shall grant any extension of time inconsistent with the
2 requirements of this Subsection (d)(2).

3 (3) The ~~Bureau~~ Department of Building Inspection shall notify the Planning
4 Department ~~of City Planning~~ in writing of its approval for issuance and issuance of a site or
5 building permit for any office development, and for any development under the jurisdiction of
6 the Successor Agency to the Redevelopment Agency of the City and County of San Francisco
7 ~~Redevelopment Agency~~ or the Port Commission subject to Section 321(a)(2), and of the
8 revocation, cancellation, or expiration of any such permit.

9 (e) **Rules and Regulations.** The ~~City~~ Planning Commission shall have authority to
10 adopt such rules and regulations as it may determine are appropriate to carry out the
11 purposes and provisions of this Section and Sections 320, 322 and 323.

12 **SEC. 321.1. ANNUAL LIMIT ADJUSTMENT.**

13 (a) It is the intention of the people of San Francisco that the annual limit on office
14 development be reduced to account for the square footage resulting from the excessive
15 number of building, alteration and site permits that were issued after November 29, 1984, the
16 date the ~~City~~ Planning Commission amended the General Master Plan to include the
17 Downtown Plan.

18 (b) Not later than January 1, 1987 and January 1st of each subsequent year, the
19 Planning Department ~~of City Planning~~ shall survey the records of the Central Permit Bureau
20 and any other necessary records to develop a list of the square footage of all office
21 development projects for which building, alteration or site permits were issued after November
22 29, 1984 that have not lapsed or otherwise been revoked, and all office development projects
23 reapproved by the City, the Successor Agency to the Redevelopment Agency of the City and County
24 of San Francisco Redevelopment Agency or the San Francisco Port Commission after November
25 29, 1984. Reapproval specifically includes any project reconsidered by any agency pursuant

1 to a Court decision. This process shall continue until the Department is able to certify that all
2 projects with approval dates on or before November 4, 1986 have received permits, have
3 been abandoned or are no longer subject to litigation challenging their approval.
4 Notwithstanding any other provision of the ~~City~~ Planning Code or the former provisions of
5 Subsection 320(g), all projects in excess of 24,999 square feet of additional office space shall
6 be included in the survey. The list shall not include permits for projects authorized pursuant to
7 the office development competition set out in Subsection 321(b) and Section 322.

8 (c) Not later than February 1, 1987 and February 1st of each subsequent year as set
9 out above, the Department shall certify in writing to the ~~City~~ Planning Commission at a public
10 hearing the list of all projects enumerated in Subsection (b) above, including the square
11 footage of each project and the total of all such projects.

13 **SEC. 322. PROCEDURE FOR ADMINISTRATION OF OFFICE DEVELOPMENT LIMIT.**

14 (a) **Project Authorization Required.** During the approval period, every site or building
15 permit application for an office development must, before final action on the permit, include a

17 Planning Department of City Planning. No such application shall be considered complete and
18 the Department of ~~Public Works~~ Building Inspection shall not issue any such site or building
19 permit unless such a certified copy is submitted. No site or building permit shall be issued for
20 an office development except in accordance with the terms of the project authorization for
21 such office development. Any such site or building permit which is inconsistent with the project
22 authorization shall be invalid.

23 (b) **Application for Project Authorization.** During the approval period, an applicant
24 for approval of an office development shall file an application for a project authorization with
25 the Planning Department of City Planning contemporaneously with the filing of an application

1 for environmental evaluation for such development. Such application shall state such
2 information as the Planning Department ~~of City Planning~~ shall require; provided, however, that
3 an application for a project authorization for each office development for which an
4 environmental evaluation application has been filed prior to the effective date of this Section,
5 shall be deemed to have been filed effective as of the date such environmental evaluation
6 application was filed.

7 (c) **Processing of Applications.**

8 (1) The approval period shall be divided into such review periods as the
9 Planning Commission shall provide by rule. The first review period shall commence on the
10 effective date.

11 (2) Applications for project authorizations shall be considered by the ~~City~~
12 Planning Commission during a specific review period in accordance with the following
13 procedures:

14 (A) During a specific review period the ~~City~~ Planning Commission shall
15 consider all project authorization applications for which, prior to the first day of such review
16 period, a final Environmental Impact Report has been certified, or a final Negative Declaration
17 has been issued, or other appropriate environmental review has been completed; provided,
18 however, that during the first review period, the ~~City~~ Planning Commission shall consider only
19 those office developments for which (i) an environmental evaluation application and a site or
20 building permit application were submitted prior to June 1, 1985, or (ii) a draft environmental
21 impact report or a preliminary negative declaration was published prior to the effective date.

22 (B) The ~~City~~ Planning Commission may hold hearings on all project
23 authorization applications assigned to a specific review period before acting on any such
24 application.

1 (C) In reviewing project authorization applications, the *City* Planning
2 Commission shall apply the criteria set forth in Section 321, and shall, prior to the end of such
3 a review period, approve, deny, or, with the consent of the applicant, continue to the next
4 subsequent review period each such application based on said criteria.

5 (D) Notwithstanding any other provisions of this Section or Section 321,
6 the *City* Planning Commission may at any time, after a noticed hearing, deny or take other
7 appropriate action with respect to any application for a project authorization as to which
8 environmental review, in the judgment of the Commission, has not been or will not be
9 completed in sufficient time to allow timely action under applicable law.

10 (E) Any project authorization application which is denied by the *City*
11 Planning Commission, unless such denial is reversed by the Board of *Permit* Appeals or
12 Board of Supervisors, shall not be resubmitted for a period of one year after denial.

13 (d) **Appeal of Project Authorization.** The *City* Planning Commission's determination
14 to approve or deny the issuance of a project authorization may be appealed to the Board of
15 *Permit*-Appeals within 15 days of the Commission's issuance of a dated written decision
16 pursuant to the procedural provisions of Section 308.2 of this Code, except in those instances
17 where a conditional use application was filed. In cases in which a conditional use application
18 was filed, the decision of the *City* Planning Commission may be appealed only to the Board of
19 Supervisors pursuant to Section 308.1 of this Code. The decision on the project authorization
20 by the Board of *Permit* Appeals or Board of Supervisors shall be the final administrative
21 determination as to all matters relating to the approval of the office development that is the
22 subject of the project authorization, except for matters, not considered in connection with the
23 project authorization, which arise in connection with a subsequent building or site permit
24 application for the development in question.

1 (e) **Modification of Project Authorization.** The *City* Planning Commission may
2 approve a modified project authorization, after a noticed hearing, during the review period in
3 which the initial project authorization was approved or a subsequent review period. Approval
4 or denial of a modified project authorization shall be subject to appeal in accord with
5 Subsection (d).

7 **SEC. 323. OFFICE DEVELOPMENT: PREAPPLICATION PROCEDURE.**

8 The *City* Planning Commission may by rule permit such persons as elect to do so, to
9 submit a preliminary application on a proposed office development before submitting any
10 application for a project authorization. Such a preliminary application shall contain such
11 information as the Commission may require. With respect to each proposed office
12 development for which all the information required by the *Planning Department of City Planning*
13 is timely submitted to the Department, the Director of Planning or his designee shall, in
14 writing, issue an advisory opinion to the person submitting such information, as to whether he
15 or she at that time intends to recommend, based on the information submitted to him or her,
16 the proposed development for denial by the *City* Planning Commission. The advice and
17 recommendation of the Director shall neither convey, nor foreclose, any right to proceed with

14 a total square footage of office space no greater than that which would otherwise be permitted
15 by the project.

16 (B) ~~Office~~ ~~Uses~~ are consolidated within a lesser number of buildings
17 than would otherwise be the case, and

18 (C) the resulting location and mix of uses increases the project's
19 consistency with nearby land uses;

20 (9) Relief from dwelling unit exposure requirements for buildings which are
21 designated landmark buildings or contributory buildings within designated historic districts
22 under Article 10 of this Code, and/or buildings recorded with the State Historic Preservation

1 (a) An application for a Coastal Zone Permit where a ~~e~~Conditional ~~u~~Use authorization is
2 required shall be reviewed subject to the procedures for reviewing conditional use applications
3 in Section 303 of the ~~City~~ Planning Code.

4 (b) An application for a Coastal Zone Permit where a variance application is required
5 shall be reviewed subject to the procedures for variances in Section 305 of the ~~City~~ Planning
6 Code.

7 (c) An application for a Coastal Zone Permit where a building permit authorization is

13 **SEC. 330.5.2. FINDINGS.**

14 The Zoning Administrator or the ~~City~~ Planning Commission, or Board of ~~Permit~~ Appeals
15 in reviewing a Coastal Zone Permit Application or an appeal thereof shall adopt factual
16 findings that the project is consistent or not consistent with the Local Coastal Program. A

6 (1) **Application.** The California Mitigation Fee Act, Government Code Section
7 66000 et seq. may apply to some or all of the fees in this Article ~~4~~. While the Mitigation Fee
8 Act may not apply to all fees, the Board has determined that general compliance with its
9 provisions is good public policy in the adoption, imposition, collection, and reporting of fees
10 collected under this Article ~~4~~. By making findings required under the Act, including the
11 findings in this ~~s~~ubsection and findings supporting a reasonable relationship between new
12 development and the fees imposed under this Article ~~4~~, the Board does not make any

15 (2) **Timing of Fee Collection.** For any of the fees in this Article ~~4~~ collected

17 following findings set forth in California Government Code Section 66007(b): the Board of
18 Supervisors finds, based on information from the Planning Department in Board File No.
19 150149, that it is appropriate to require the payment of the fees in Article ~~4~~ at the time of
20 issuance of the first construction document because the fee will be collected for public
21 improvements or facilities for which an account has been established and funds appropriated
22 and for which the City has adopted a proposed construction schedule or plan prior to the final
23 inspection or issuance of the certificate of occupancy or because the fee is to reimburse the
24 City for expenditures previously made for such public improvements or facilities.

1 (3) **Administrative Fee.** The Board finds, based on information from the

14 the *San Francisco* Planning Code collected during the prior two fiscal years organized by
15 development fee account and all cumulative monies collected over the life of each
16 development fee account, as well as all monies expended. The report shall include: (1) a
17 description of the type of fee in each account or fund; (2) the beginning and ending balance of
18 the accounts or funds including any bond funds held by an outside trustee; (3) the amount of
19 fees collected and interest earned; (4) an identification of each public improvement on which
20 fees or bond funds were expended and amount of each expenditure; (5) an identification of
21 the approximate date by which the construction of public improvements will commence; (6) a
22 description of any inter-fund transfer or loan and the public improvement on which the
23 transferred funds will be expended; and (7) the amount of refunds made and any allocations
24 of unexpended fees that are not refunded. The report shall also provide information on the
25 number of projects that elected to satisfy development impact requirements through the

1 provision of "in-kind" physical improvements, including on-site and off-site BMR units, instead
2 of paying development fees. The report shall also include any annual reporting information
3 otherwise required pursuant to the California Mitigation Fee Act, Government Code 66001 et
4 seq. The report shall be presented by the Director of Planning ~~Director~~ to the Planning
5 Commission and to the Land Use & Economic Development Committee of the Board of
6 Supervisors. The Report shall also contain information on the Controller's annual construction
7 cost inflation adjustments to development fees described in subsection (b) below, as well as
8 information on MOH's separate adjustment of the Jobs-Housing Linkage and Inclusionary
9 Affordable Housing fees described in Sections 413.6(b) and 415.5(b)(3).

11 **SEC. 411.3. APPLICATION OF TIDF.**

12 (a) **Application.** Except as provided in Subsections (1) and (2) below, the TIDF shall
13 be payable with respect to any new development in the City for which a building or site permit
14 is issued on or after September 4, 2004. In reviewing whether a development project is
15 subject to the TIDF, the project shall be considered in its entirety. A sponsor shall not seek
16 multiple applications for building permits to evade paying the TIDF for a single development
17 project.

19 (2) No TIDF shall be payable on the following types of new development.

20 (A) New development on property owned (including beneficially owned)
21 by the City, except for that portion of the new development that may be developed by a
22 private sponsor and not intended to be occupied by the City or other agency or entity
23 exempted under Section 411.1 et seq., in which case the TIDF shall apply only to such non-
24 exempted portion. New development on property owned by a private person or entity and
25 leased to the City shall be subject to the fee, unless the City is the beneficial owner of such

1 new development or unless such new development is otherwise exempted under this Section.

7 below 80% of the area's median income, and even those earning moderate or middle
8 incomes, above the City's median, are likely to need assistance to continue to live in San
9 Francisco. In 2007, the median income for a family of four in the eCity was about \$86,000. Yet
10 median home prices suggest that nearly twice that income is needed to be able to *afford* a
11 dwelling suitable for a family that size. Only an estimated 10% of households in the eCity can
12 afford a median-priced home.

13 The Association of Bay Area Governments' (ABAG) Regional Housing Needs
14 Determination (RHND) forecasts that San Francisco must produce over 31,000 new units in
15 the next five years, or over 6,000 new units of housing annually, to meet projected needs. At
16 least 60%, or over 18,000, of these new units should be available to households of very low,
17 low, and moderate incomes. With land in short supply in the City, it is increasingly clear that
18 the City's formerly industrial areas offer a critical source of land where this great need for
19 housing, particularly affordable housing, can be partially addressed.

22 also principal permitted uses. Residential uses, large hotels, adult entertainment and heavy

SEC. 846. SALI – SERVICE/ARTS/LIGHT INDUSTRIAL DISTRICT.

The Service/Arts/Light Industrial (SALI) District is largely comprised of low-scale buildings with production, distribution, and repair uses. The district is designed to protect and facilitate the expansion of existing general commercial, manufacturing, home and business service, and light industrial activities, with an emphasis on preserving and expanding arts activities. Nighttime ~~e~~Entertainment is permitted although limited by buffers around RED and RED-MX districts. Residential ~~u~~Uses, ~~o~~Offices, ~~h~~Hotels, ~~movie theaters~~, and ~~a~~Addult ~~e~~Entertainment uses are not permitted.
