10 Be it ordained by the People of the City and County of San Francisco:


11 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby  
12 authorizes the City Attorney to settle the action entitled David Lloyd v. City and County of San  
13 Francisco et al., United States District Court, Case No. 3:14-cv-03542 JCS by the payment of  
14 \$42,500, which will include payment of the medical lien held by San Francisco General  
15 Hospital.

16 Section 2. The above-named action was filed in Superior Court of the City and County  
17 of San Francisco on June 10, 2014, initially entitled David Lloyd v. City and County of San  
18 Francisco, et al; Case No. CGC-14-539774 and removed to the United States District Court  
19 on August 6, 2014, and re-captioned as David Lloyd v. City and County of San Francisco, et  
20 al. and the following parties were named in the lawsuit: Plaintiff: David Lloyd; Defendants:




