

1 INCREASING CIVIL FILING AND APPEARANCE FEES PROVIDED IN BUSINESS AND  
2 PROFESSIONS CODE SECTIONS 6321, 6322 AND 6322.1 FOR OPERATION OF THE  
3 LAW LIBRARY  
4

5 WHEREAS, the Law Library's filing fee income is inadequate to meet present and  
6 anticipated future operating costs of the Law Library: legal publication costs, salaries and general  
7 operating expenses have increased and are expected to increase yearly, and automated reference  
8 resources and library systems must be acquired and maintained; so that an increase in the filing  
9 and appearance fees pursuant to Section 6322.1 of the Business and Professions Code of the  
10 State of California fund Law Library operations is required:

11 WHEREAS, California Business and Professions Code section 6322.1 empowers this  
12 Board of Supervisors to increase Law Library civil filing fees from \$21.00 to \$24.00 by  
13 excluding the increase from the definition of "total fee" provided in sections 26820.6 and 72055  
14 of the Government Code; and

15 WHEREAS, the increased fee does not affect the City and County General Fund or the  
16 Trial Court Trust Fund established by Government Code section 68085; now, therefore, be it

17 RESOLVED, that the Board of Supervisors of the City and County of San Francisco  
18 hereby orders that the fees for use of the Law Library, provided in sections 6321 and 6322 of the  
19 California Business and Professions Code be increased from \$21.00 to \$24.00 in Superior and  
20 Municipal Court effective January 1, 1999; and be it

21 RESOLVED, that pursuant to Government Code section 6322.1, the three dollar (\$3.00)  
22 increase in Law Library filing fees is specifically excluded from the definition of "total filing  
23 fee" in the above-referenced provisions of the Government Code, and therefore, that three dollars  
24 (\$3.00) of the fee be added to the total filing fees in Superior and Municipal Courts; and be it

FURTHER RESOLVED, that the Clerk of the Board of Supervisors be and is hereby directed to deliver copies of this resolution, duly certified, to the Superior Court and the Clerk of the Municipal Court of the City and County of San Francisco.




