3 **Resolution authorizing the Municipal Transportation Agency to accept and expend \$11,283,000**
4 **of Regional Measure 2 funds for the Automatic Vehicle Location System project.**

6 WHEREAS, On March 2, 2004, voters in seven Bay Area counties cumulatively passed
7 Regional Measure 2, under which the tolls on the nine State-owned toll bridges in the San Francisco
8 Bay Area will increase by \$1.00 effective July 1, 2004; and,

9 WHEREAS, Regional Measure 2 will raise an estimated \$125 million each year to implement
10 the Regional Traffic Relief Plan, which includes transit operating assistance and funding of specified
11 capital projects within the region that have been determined to reduce congestion or make
12 improvements to travel in the toll bridge corridors; and

13 WHEREAS, As the transportation planning, coordinating and financing agency of the nine-
14 county Bay Area, the Metropolitan Transportation Commission (MTC) allocates Regional Measure 2
15 funding; and,

16 WHEREAS, The Municipal Transportation Agency of the City and County of San Francisco
17 (MTA) is an eligible sponsor of transportation project(s) in Regional Measure 2, Regional Traffic
18 Relief Plan funds; and

19 WHEREAS, The MTA's Automatic Vehicle Location System project is eligible for
20 consideration in the Regional Traffic Relief Plan of Regional Measure 2, as identified in California
21 Streets and Highways Code Section 30914(c) or (d); and

22 WHEREAS, The MTA has applied to MTC for \$11,283,000 for the Automatic Vehicle
23 Location System project; now, therefore be it,


