5 WHEREAS, Scott Hall is the founder of Gay American Heroes, a project dedicated to
6 over 700 victims of gay hate crimes in America; and

8 WHEREAS, Scott has developed the Gay American Heroes Memorial, a traveling
9 multi-dimensional structure over 7-feet high and more than 75 feet in length that includes the
10 names, ages, and geographical information of the heroes; and,

12 WHEREAS, The Memorial will travel to LGBT related events, college campuses,
13 community centers, and most importantly, any city where a hate crime has occurred; and

15 WHEREAS, The Gay American Heroes Memorial is a powerful way to inspire a
16 dialogue and educate communities about the serious issues facing LGBT individuals; and;

18 WHEREAS, Gay American Heroes Foundation, with the support of sister
19 organizations, works to support the family and friends of the victim, as well as working with
20 local officials, law enforcement, and service organizations to provide counseling and
21 outreach; now, therefore, be it
