3 **Ordinance authorizing settlement of the lawsuit filed by Jeffrey Paillet against the City**  
4 **and County of San Francisco for \$835,000; the lawsuit was filed on November 2, 2021,**  
5 **in San Francisco Superior Court, Case No. CGC-21-596176; entitled Jeffrey Paillet v.**  
6 **City and County of San Francisco, et al.; the lawsuit involves an employment dispute.**

8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
10 authorizes the City Attorney to settle the action entitled Jeffrey Paillet v. City and County of  
11 San Francisco, et al., San Francisco Superior Court, Case No. CGC-21-596176 by the  
12 payment of \$835,000. The lawsuit involves an employment dispute.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 November 2, 2021, and the following parties were named in the lawsuit: Plaintiff: Jeffrey  
16 Paillet; Defendants: City and County of San Francisco, Chesa Boudin, David Campos, Dana
