3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH),**  
4 **Laguna Honda Hospital & Rehabilitation Center (LHH) to accept and expend a**  
5 **monetary gift donation to Laguna Honda Hospital in the amount of \$50,000 from**  
6 **the Mildred Oliva Trust, through Shirley A. Reece, Trustee, for the exclusive**  
7 **benefit of the residents of the LHH Hospice Unit.**

9 WHEREAS, the Mildred Oliva Trust, a private donor has donated the amount of  
10 \$50,000 in support of the Hospice Unit to provide for the comforts and well-being of their  
11 residents; and

13 WHEREAS, Laguna Honda Hospital and Rehabilitation Center is a public  
14 hospital that provides health-care services to the adult citizens of San Francisco who  
15 are disabled or chronically ill; and

17 WHEREAS, LHH Hospice Department has committed to continue provide the  
18 best quality of care at the end of life and support the needs of the residents, their  
19 families and friends; and

21 WHEREAS, The money will be used for enhancing the Hospice C-2  
22 environment and the comfort and quality of life of patients and loved ones: 1) Food and  
23 supplies for birthdays, happy hour and other special events. 2) Decorating and  
24 furnishing common areas, refurbishing the Hospice Memorial Garden, purchasing

1 televisions and CD players and other amenities for bedridden patients. Expenses will  
2 conform to criteria used in the existing Patient Gift Fund.

3 WHEREAS, the Department wishes to obtain approval from the Health  
4 Commission and the Board of Supervisors to accept the donation of funds on behalf  
5 of LHH Hospice Unit to provide aid and support and comfort of the residents; and  
6 now, therefore; be it

8 FURTHER RESOLVED, That the SFDPH, Laguna Honda Hospital and  
9 Rehabilitation Center is hereby authorized to accept and expend the funds in  
10 accordance with the requirements set forth pursuant to San Francisco Administrative  
11 Code Section 10.100-305, and Code Section 10.100-201; and, be it

13 FURTHER RESOLVED, That the SFDPH, Laguna Honda Hospital and  
14 Rehabilitation Center is hereby authorized to accept and expend the monetary gift  
15 donation in the amount of \$50,000 from the Mildred Oliva Trust, via Shirley Reece,  
16 Trustee, for the LHH, Hospice Unit.
