2 AMENDING SECTION 32.6.19 OF THE SAN FRANCISCO TRAFFIC CODE, REGARDING  
3 PARKING REGULATIONS ON A PORTION OF STANFORD STREET.

4 Note: Additions or substitutions are underlined.

5 Deletions are shown in ((double parentheses)).

6 Be it ordained by the people of the City and County of San Francisco:

7 Section 1. Article 3 of the San Francisco Traffic Code is hereby amended by amending  
8 Section 32.6.19 thereof to read as follows:

9 **SEC. 32.6.19. PARKING CONTROL, PORTIONS OF 2<sup>ND</sup> STREET, STANFORD**  
10 **STREET, AND TOWNSEND STREET; PENALTIES FOR VIOLATION.** No person shall stop,  
11 park, or leave standing any vehicle, whether attended or unattended, ((on the west side of 2<sup>nd</sup>  
12 Street, from Townsend Street to 100 feet northerly (100-foot zone), and on the north side of  
13 Townsend Street, between 2<sup>nd</sup> and Stanford Streets,)) at the following locations:

14 (a) 2<sup>nd</sup> Street, west side, from Townsend Street to 100 feet northerly (100-foot zone);

15 (b) Stanford Street, east side, from Townsend Street to 100 feet northerly (100-foot  
16 zone); and

17 (c) Townsend Street, north side, between 2<sup>nd</sup> and Stanford Streets

18 except official City-owned vehicles displaying a valid permit issued by the San Francisco Fire  
19 Department authorizing parking in such zones. The permit exceptions under this Section shall  
20 not apply when parking prohibition regulations for street-cleaning purposes are in effect.  
21 Violation of this Section is an obstruction to the free use of property and a nuisance within the  
22 meaning of Division 4, Part III of the Civil Code of California relating to nuisance and the  
23 abatement thereof.

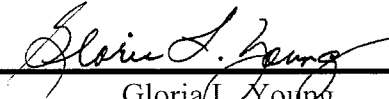

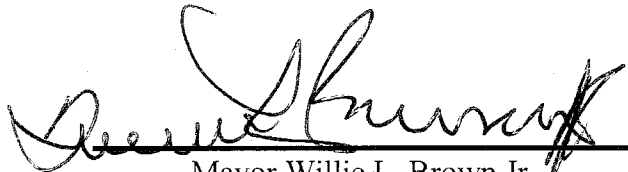
