6 MOVED, That the Board of Supervisors of the City and County of San Francisco does
7 hereby appoint the hereinafter designated person to serve as a member of the San Francisco
8 Sentencing Commission, pursuant to the provisions of Board of Supervisors Ordinance No.
9 10-12 for the term specified:

10 Theshia Naidoo, seat 1 (residency requirement waived), new appointment, must be a
11 sentencing expert, for a term to be determined.

12 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 13 1. The membership of the San Francisco Sentencing Commission has a goal to be
14 representative of the diversity of the City and County of San Francisco.
- 15 2. Applicant Theshia Naidoo, a new appointee, who is not a resident of San Francisco,
16 is a person with experience that uniquely qualifies her to serve on the San
17 Francisco Sentencing Commission.
- 18 3. The San Francisco Sentencing Commission has attempted to fill the position, for
19 which Theshia Naidoo was nominated, with an individual who is a City resident and
20 who has the specific experience, skills, and qualifications, but has been unable to

Statement of Qualifications for Theshia Naidoo

I am an attorney with the Drug Policy Alliance (DPA), Office of Legal Affairs. For over seven years, I have worked on a wide range of areas throughout criminal justice and drug policy reform, including litigation, legislative work, technical assistance, and public education. As an attorney at DPA, I advocate for policies aimed at minimizing the harms of drug abuse and redirecting resources away from inefficient, ineffective, and unnecessarily punitive practices. My work is focused on promoting and implementing evidence based alternatives to policies that arrest, incarcerate, disenfranchise, and otherwise harm millions of nonviolent people.

My direct experience working on sentencing reform throughout the criminal justice system, from pre-arrest through post-conviction, includes:

- Evaluating California's drug sentences and serving as the lead DPA attorney on a legislative campaign, initiated by State Senator Mark Leno, to reduce penalties and reclassify drug possession offenses from felonies to misdemeanors;
- Working with the Dignity in Schools Campaign to evaluate school policies that contribute to school drop-out rates and fuel the school-to-prison pipeline. I also assisted with drafting a Model School Code to implement best practices based on fundamental human rights;
- Evaluating and proposing amendments to California's policies that contributed to the prison overcrowding crisis and being one of the primary drafters of Proposition 5, the Nonviolent Offender Rehabilitation Act, which was on the California ballot in 2008; and
- Working on Proposition 36 implementation issues, including serving as co-counsel in a lawsuit that successfully challenged legislative amendments to Prop 36 that were contrary to sound practices and would have allowed counties to incarcerate Prop 36 participants.

In addition to California, I have experience evaluating drug sentencing laws in a number of other states. I have worked on legislative proposals to promote alternatives to incarceration and recommended amendments to existing laws to implement front-end sentencing reforms with the aim of reducing recidivism. I have been actively involved in the legislative process and have worked on bills that seek to roll back the excesses of the drug war, block new, harmful initiatives, and promote sensible drug policy reforms. Further, I am familiar with the research on evidence-based practices, understand theories about sentencing reform and have collaborated with experts and organizations who are documenting the impact of current sentencing practices and developing and evaluating new practices.

About the Drug Policy Alliance

The Drug Policy Alliance (“DPA”) is a major advocate for sentencing reform in California, having sponsored three measures on the California ballot since 1996 (Prop 215, Prop 36 and Prop 5). In particular, our organization has significant alternative sentencing expertise. Under Prop 36, which passed with 61% of the vote in 2000, over 200,000 drug possession offenders have already been diverted from prison to alternative sentencing in California (according to researchers at the University of California at Los Angeles).

DPA’s Office of Legal Affairs, based in Berkeley, pursues these goals nationwide through impact litigation, legislative drafting for local and state bodies, and advocacy on behalf of public health interventions that address the problems associated with substance abuse at the individual, family and community levels.

Our office works with our state-based and Washington, DC offices on legislation related to a variety of issues, including but not limited to: reforming sentencing laws, including advocating for treatment instead of incarceration; reduction of suspicion-less drug testing and other pervasive surveillance technologies; eligibility for public benefits for individuals with drug problems or prior drug convictions; access to substance abuse treatment, including narcotic replacement therapies; provision of harm reduction services, including access to sterile syringes and overdose prevention programs; lawful use and supply of medical marijuana; adequate treatment of severe and chronic pain; combating the criminalization of pregnant substance abusers; and addressing racial disparities in drug laws and sentencing.

In addition to the Office of Legal Affairs, DPA maintains six other offices: in San Francisco and Los Angeles, California; New Mexico; New Jersey; New York; and Washington, DC.

Qualifications, business and professional experience:

I am an attorney and the Criminal Justice and Drug Policy Director of the ACLU of Northern California. I work in the San Francisco office of the ACLU to develop and implement strategies to reform California's criminal justice system and drug policies. Specific areas of focus and expertise include sentencing reform, down-sizing California jails and prisons, drug law enforcement, medical marijuana implementation issues and broader marijuana law reform. I have co-authored two major ACLU reports on criminal justice realignment, available on our website at www.aclunc.org/realignment. I have attended and/or presented at numerous conferences and panels concerning criminal justice realignment since its inception last year. I have studied sentencing reform efforts from around the country and am in regular communication with ACLU offices in other states throughout the country about criminal justice and sentencing reform developments and issues. Prior to joining to the staff of the California ACLU, I was the Litigation Director of the National ACLU's Drug Law Reform Project, where I coordinated the ACLU's drug policy-related litigation and litigated cases across the nation as part of an overall strategy to combine impact litigation with policy and legislative advocacy, public education, media and grassroots-and-tops organizing to transform public understanding of, and government response to, drug use and drug policies. I published an analysis of the continued validity of state medical marijuana laws after the U.S. Supreme Court's 2005 decision in *Gonzales v. Raich*, and a similar analysis of the constitutional validity of California's 2010 marijuana legalization voter initiative, Proposition 19. I have been quoted extensively in the state and national news media on criminal justice realignment issues and numerous marijuana law reform topics. I testified as a constitutional law expert in October, 2009 before the California State Assembly Public Safety Committee during its hearings on the legalization of marijuana.

I received my undergraduate degree in 1988 from New College of Florida, the independent public honors college for the state of Florida, and my law degree from the University of California, Davis, School of Law in 1992, where I was the recipient of the Martin Luther King, Jr., Award for Public Service. Before joining the ACLU staff, I worked in private practice focusing on criminal defense, prisoners' rights and police misconduct litigation and was also a staff attorney for the California Appellate Project in San Francisco, established by the California Supreme Court and the State Bar to oversee and provide case assistance to the lawyers appointed by the Court to represent death row defendants in their state and federal post-conviction proceedings.

Board Qualifications:

The Commission shall consist of 12 members, or 13 members if the Superior Court agrees to provide one member. The head or chair of each of the following agencies and bodies shall serve on or will assign one staff member to serve on the Commission as a voting member; District Attorney; Public Defender; Adult Probation; Juvenile Probation; Sheriff; Police; the Department of Public Health; the Reentry Council, and the Superior Court, assuming it agrees to participate on the Commission. In addition, the following additional voting members will be appointed: a member of a nonprofit organization that works with victims, chosen by the Family Violence Council; a member of a nonprofit organization that works with ex-offenders, chosen by the Reentry Council; a sentencing expert chosen by the Board of Supervisors; and an academic researcher with expertise in data analysis appointed by the Mayor.

The Commission shall have the following powers and duties:

- (a) Review and assess sentencing approaches locally and compare to other jurisdictions.
- (b) Review and assess the City's capacity and utilization of services and alternatives to incarceration throughout the criminal justice continuum, including pre-adjudication and post-release.
- (c) Review and assess the Justice Reinvestment Initiative recommendations to invest in best practices to reduce recidivism.
- (d) Develop a recommended system of uniform definitions of recidivism for City departments to track and report on the outcomes of various criminal sentences and City programs meant to aid in reducing recidivism.
- (e) Develop data collection standards and recidivism reporting standards.

(f) Develop and recommend department specific goals to reduce recidivism for the City departments represented on the Sentencing Commission, and other relevant City departments.

(g) Make recommendations regarding changes that should be made to the Penal Code and any other state laws to remove barriers to effective implementation of best practices in criminal justice.

(h) Facilitate trainings on best practices in sentencing for various criminal justice agencies.

(i) Share information and work in collaboration with the Reentry Council, established pursuant to the San Francisco Administrative Code, and the Community Corrections Partnership, as established by the California Penal Code.

Meeting Frequency: The Commission shall meet at least three times a year.

Report: In December 2012, and on an annual basis thereafter, submit a report to the Mayor and the Board of Supervisors summarizing the findings of the Commission and making recommendations on the aforementioned categories.

Sunset Date: This legislation shall expire on June 1, 2015, unless the Board of Supervisors adopts an ordinance continuing its existence. The Commission shall submit a report to the Board of Supervisors no fewer than six months prior to the expiration date recommending whether the Commission should continue to operate, and if so, whether the Board of Supervisors shall consider legislative changes that would enhance the capacity of the Commission to achieve the goals underlying this ordinance. The Commission's recommendations shall include drafts of ordinances that would implement its recommendations.
