

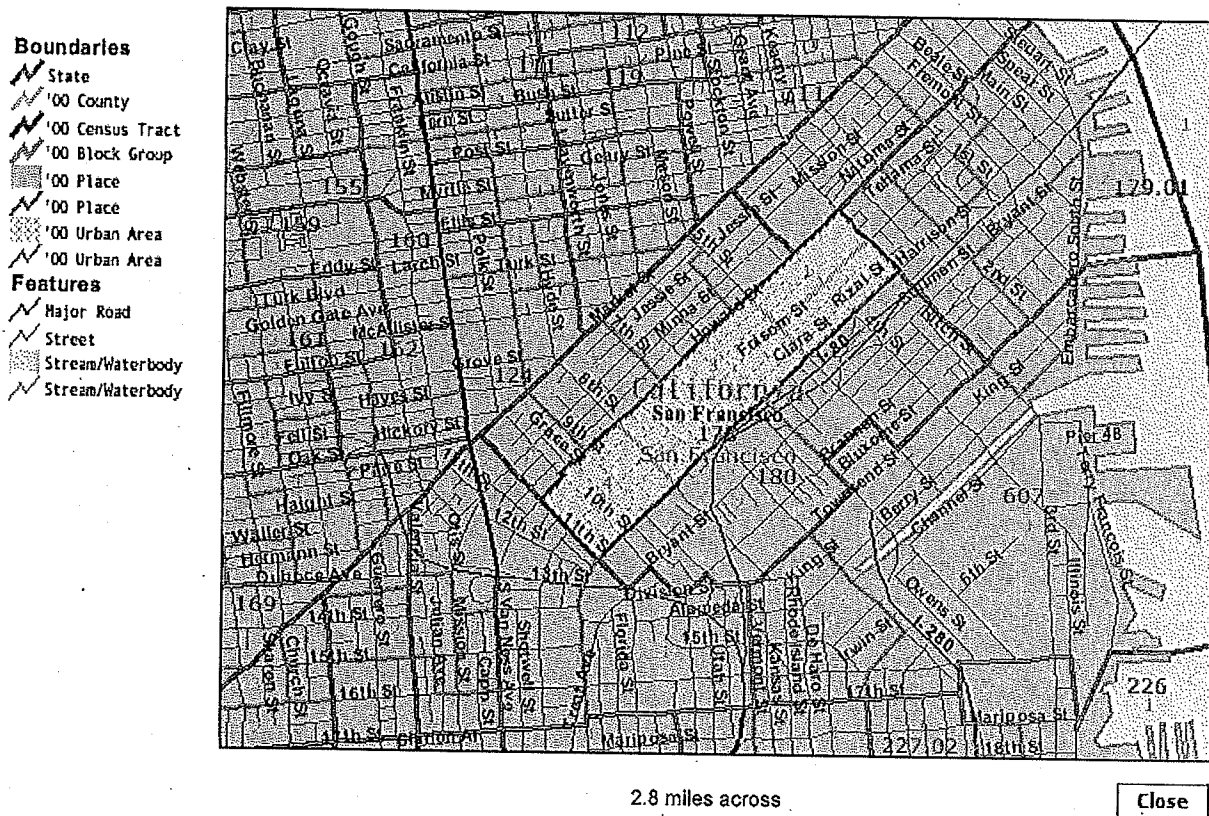
ALU Recommendation: **Approval with Conditions**

1. Sales of alcoholic beverages shall be permitted between the hours of 8:00 a.m. and midnight daily.
2. The sale of beer or malt beverages in quantities of 32 oz., or larger size containers is strictly prohibited.
3. No malt beverage shall be sold with an alcoholic content greater than 6 % by volume.
4. Noise ("noise is defined as any raucous sound that is produced in such a manner or to such a degree as to disturb the peace, quiet, and comfort of persons in the neighborhood") shall not be audible beyond the area under the control of the licensee as depicted on ABC-257, dated \_\_\_\_\_.
5. The petitioner shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control.
6. Loitering (loitering is defined as "to stand idly about; linger aimlessly without lawful business") is prohibited on any sidewalks or property adjacent to the licensed premises under the control of the licensee as depicted on the ABC-257, dated \_\_\_\_\_.

7. There shall be no cups, glasses, or similar receptacles commonly used for the drinking of beverages, sold, furnished, or given away at the petitioner's premises in quantities of less than twenty-four (24) in their original multi-container package.
8. All ice shall be sold at or above prevailing prices in the area and in quantities of not less than three (3) pounds per sale and shall not be given away free.
9. No person under the age of 21 shall sell or deliver alcoholic beverages.
10. No wine shall be sold with an alcoholic content of great than 15% by volume except for "Dinner Wines" which have been aged two years or more and maintained in corded bottles.

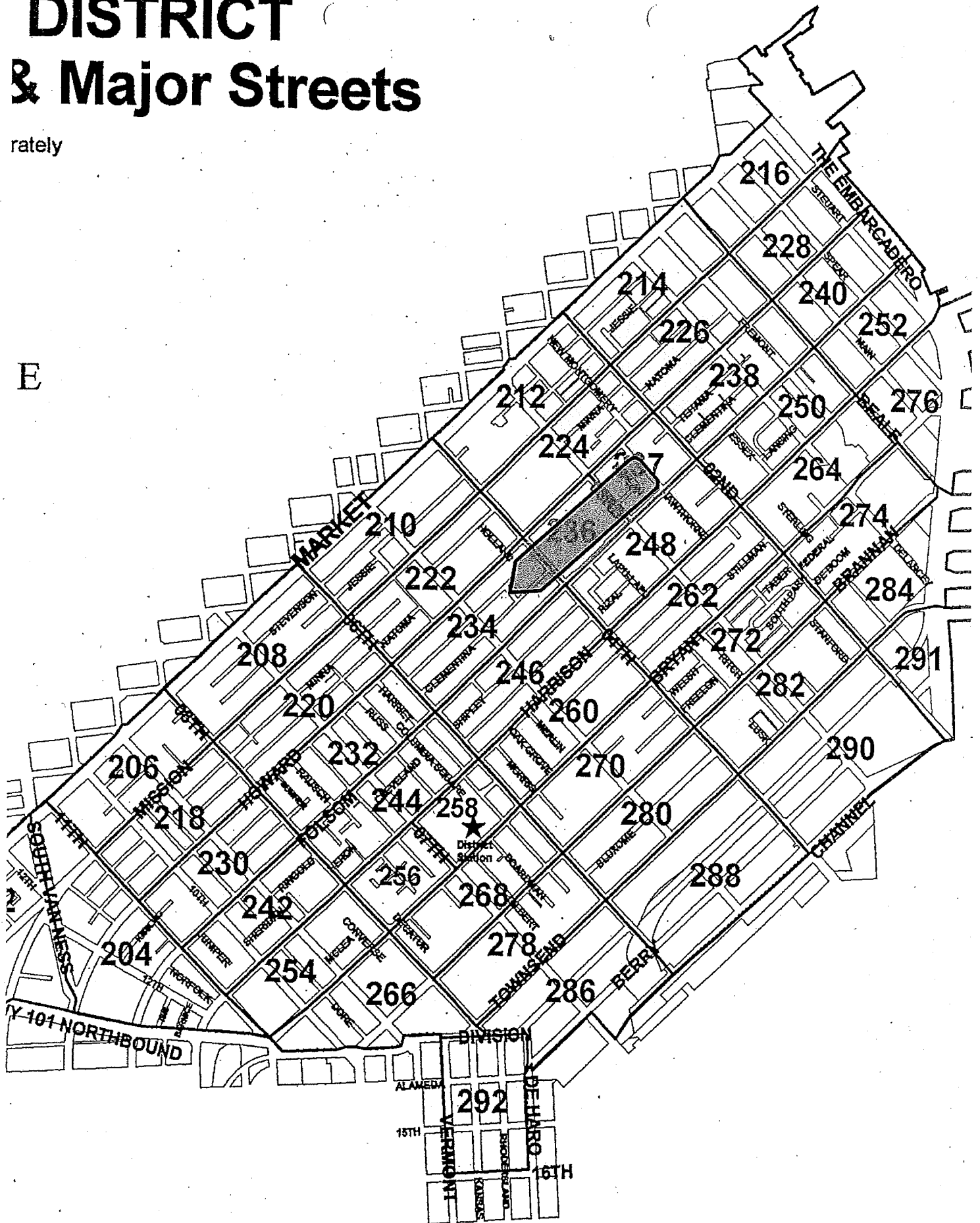
Census Tract 178, San Francisco County, California
