13 WHEREAS, Under title i of the housing and community development act of 1974, as

14 amended, and related federal regulations, San Francisco is eligible to receive a community

15 development block grant; and

16 WHEREAS, The Mayor's Office of Community Development has prepared programs

17 entitled Final Recommendations for the 2001 Community Development Block Grant, and the

18 Expenditure Schedules for an anticipated entitlement, and reprogrammed funds from prior

19 year Community Development Programs and program income generated by the Mayor's

20 Office of Community Development and the San Francisco Redevelopment Agency as needed,

21 up to \$38,663,433; and

23 WHEREAS, The City will receive \$25,820,000 in 2001 CDBG Program funds; and

24 WHEREAS, a Preliminary Environmental Record on the Final Recommendations has

25 been prepared; and

2 WHEREAS, The Certifying Officer shall follow procedural provisions of NEPA to make  
3 certain that all projects are in compliance with the applicable federal provisions and  
4 requirements; now, therefore, be it

5 RESOLVED, That the Board of Supervisors does hereby approve the Final Proposal  
6 2001 Community Development Block Grant, to accept and expend the City's 2001 Community  
7 Development Block Grant Entitlement from the U.S. Department of Housing and Urban  
8 Development, transfer and expend reprogrammed funds from prior year Community  
9 Development Programs up to \$27,372,000 and an estimated \$11,291,433 in program income  
10 generated by the Mayor's Office of Community Development, the Mayor's Office of Housing  
11 and the San Francisco Redevelopment Agency, and authorizes the Mayor to enter into and  
12 execute contract agreements between the City and County of San Francisco and departments  
13 identified in the 2001 Community Development Program; and, be it

15 FURTHER RESOLVED, That the Board of Supervisors does hereby authorize the  
16 Mayor to enter into and execute a contract between the City and County of San Francisco and  
17 the San Francisco Conservation Corps; and, be it

19 FURTHER RESOLVED, That the City's Annual Salary Ordinance be amended to  
20 reflect the staffing identified in the expenditure schedule; and, be it

22 FURTHER RESOLVED, That indirect costs of \$160,000 have been included in this

1 FURTHER RESOLVED, That the Mayor is hereby authorized to submit documentation  
2 and certifications required by the U.S. Department of Housing and Urban Development; and,

10 assistance services to Asian Pacific Islander community across the city that will  
11 address the cultural and linguistic diversity of the Asian Pacific Islander business  
12 community.
