10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. The San Francisco Business and Tax Regulations Code is hereby amended
12 by amending Section 755, to read as follows:

13 SEC. 755. FEE SCHEDULE.

14 The amount of the fee shall be \$.50 per month per access line or \$2.50 (5 x \$.50) per
15 month per trunk line. Commencing on December 1, 1997, the amount of the fee shall be
16 \$1.00 per month per access line or \$5.00 per month per trunk line. Commencing on August 1,
17 2002, the amount of the fee shall be \$1.00 per month per access line, \$7.50 per month per
18 trunk line, and \$135 per month per high capacity trunk line. Commencing on December 1, 2002,
19 the amount of the fee shall be \$1.25 per month per access line, \$9.38 per month per trunk line, and
20 \$168.75 per month per high capacity trunk line.




