1 [Settlement of Unlitigated Claims - Stripe, Inc. - \$49,000,000]

3 **Resolution approving the settlement of the unlitigated claims filed by Stripe, Inc.**
4 **against the City and County of San Francisco for \$49,000,000; the claims were filed on**
5 **April 5, 2023, and December 3, 2024; the claims involve a refund of payroll expense,**
6 **gross receipts, homelessness gross receipts, overpaid executive gross receipts, and**
7 **commercial rents taxes, and business registration fees; other material terms of the**
8 **settlement relate to Stripe's filing position with respect to City taxes.**

10 WHEREAS, Stripe, Inc. filed claims on April 5, 2023, and December 3, 2024, against
11 the City and County of San Francisco; and

12 WHEREAS, The claims involve a refund of payroll expense, gross receipts,
13 homelessness gross receipts, overpaid executive gross receipts, and commercial rents taxes,
14 and business registration fees; and

15 WHEREAS, The Office of the Treasurer and Tax Collector has recommended
16 settlement of the claims for refund of payroll expense, gross receipts, homelessness gross
17 receipts, overpaid executive gross receipts, and commercial rents taxes, and business
18 registration fees by payment of \$49,000,000 and the parties' agreement on Stripe's filing
19 position with respect to City taxes; now, therefore, be it

20 RESOLVED, That pursuant to Administrative Code, Section 10.22, the Board of
21 Supervisors hereby authorizes the City Attorney to settle and compromise the claims for
22 refund of payroll expense, gross receipts, homelessness gross receipts, overpaid executive
23 gross receipts, and commercial rents taxes, and business registration fees by payment of
24 \$49,000,000 and the parties' agreement on Stripe, Inc.'s filing position with respect to City
25 taxes.
